MINUTES OF THE NAPA COUNTY - BOARD OF SUPERVISORS MEETING COUNTY OF NAPA

March 22, 2011

Draft Summary of the Proceedings

CALL TO ORDER; ROLL CALL

The Board of Supervisors of the County of Napa met in regular session on Tuesday, March 22, 2011, at 9:00 a.m. with the following supervisors present: Chairman Bill Dodd, Supervisors Mark Luce, Diane Dillon, Keith Caldwell and Brad Wagenknecht. The meeting was called to order by Chairman Bill Dodd.
