# MINUTES OF THE NAPA COUNTY - BOARD OF SUPERVISORS MEETING COUNTY OF NAPA

June 3, 2014

### Draft Summary of the Proceedings

The Board of Supervisors of the County of Napa met in regular session on Tuesday, June 3, 2014, at 9:00 a.m. with the following supervisors present: Chairman Mark Luce, Supervisors Brad Wagenknecht, Diane Dillon, Bill Dodd and Keith Caldwell. The meeting was called to order by Chairman Mark Luce.
