FEEL YOU COULD CONTRIBUTE:

I, believe that I can represent the citizens of the Lake Berryessa area, and this part of the county on projects and programs undertaken for Regional Parks and Open Space, and provide strategic direction for future projects, in that I have been involved with this community, and have served, at the direction of the Board of Supervisors, acting as the Board of Directors, on a citizen advisory committee, for the Napa Berryessa Resort Improvement District, for the last four years. In that capacity I have learned to review the financial history of our district, and to identify funding needs to implement State mandated improvements to our water and waste-water systems, and with the help of the County Staff and the Board of Supervisors, we were able to recommend and implement a successful funding initiative to DESIGN, BUILD, FINANCE, OPERATE AND MAINTAIN, a new (11.3) million dollar water and sewer plant, funded at a below market interest rate by the U.S. Department of Agriculture and paid for by the creation of a new Assessment District. The mandated projects were all successfully completed in a timely manner, and to the satisfaction of the Federal Bureau of Reclamation, the State of California, Napa County, and the residents of the Napa Berryessa Resort Improvement District (NBRID).
