NAPA COUNTY RESOLUTION NO. 2014-100

RATIFICATION AND CONTINUANCE OF PROCLAMATION OF LOCAL EMERGENCY

WHEREAS, Government Code section 8630 and Napa County Code section 2.80.060(A)(2) authorize and empower the Napa County Executive Officer acting as Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when the County is affected or likely to be affected by a public calamity and the Board is not in session, subject to confirmation by the Board within seven days: and

WHEREAS, on August 24, 2014 and pursuant to the foregoing provisions, the Napa County Director of Emergency Services in the absence of the Napa County Executive Officer proclaimed the existence of a local emergency by that proclamation attached hereto as Exhibit "A" and incorporated by reference herein; and

WHEREAS, the Director of Emergency Services in the absence of the County Napa Executive Officer has informed the Board that there continues to exist within Napa County a condition of extreme peril to life and property due to the earthquake in South Napa and has requested that the Board confirm her proclamation and further proclaim that a local emergency continues to exist;

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. The Board of Supervisors hereby confirms the finding of the Director of Emergency Services in the absence of the County Napa Executive Officer that conditions of extreme peril to the safety of persons and property arose within Napa County on or about 3:20 a,m. on August 24, 2014 due to the earthquake in South Napa, that such conditions continue to exist, and that such conditions warranted and continue to warrant a proclamation of local emergency.
- 2. The Board of Supervisors hereby confirms and ratifies the proclamation and orders of the Director of Emergency Services that a local emergency existed throughout Napa County, as set forth in Exhibit "A".
- 3. The Board of Supervisors further proclaims and orders that such local emergency continues to exist and that the orders previously instituted by the Director of Emergency Services as stated in Exhibit "A" shall remain in place as orders of the Board of Supervisors.
- 4. The Board of Supervisors hereby also proclaims and orders that until the local emergency is terminated the powers, functions, and duties of the Napa County Executive

Officer/Director of Emergency Services and the emergency organization of Napa County shall be those prescribed by State law and the ordinances, resolutions, and approved emergency services plans of the County of Napa.

- 5. The Director of Emergency Services in the absence of the County Napa Executive Officer or her designee is hereby ordered and directed to give this Resolution and the proclamations and orders contained therein widespread publicity and notice.
- 6. This confirmation and continuance of the proclamation of local emergency shall be reviewed by the Board of Supervisors at a regular meeting of the Board at least every 30 days until terminated, to determine the need for continuing the local emergency, and termination of the local emergency shall be proclaimed by this Board at the earliest possible date that conditions warrant.

PROCLAMATION OF LOCAL EMERGENCY

PROCLAMATION OF LOCAL EMERGENCY

WHEREAS, Government Code section 8630 and Napa County Code section 2.80.060(A)(2) authorize and empower the Napa County Executive Officer/Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when the County is affected or likely to be affected by a public calamity and the Board of Supervisors is not then in session, subject to confirmation by the Board of Supervisors within seven days thereafter; and

WHEREAS, Assistant Napa County Executive Officer acting as County Executive Officer/Director of Emergency Services by delegation has found that due to a 6.0 earthquake, a condition of extreme peril to life and property now exists in the County of Napa; and

WHEREAS, the Board of Supervisors is not presently in session;

NOW, THEREFORE, THE NAPA COUNTY EXECUTIVE OFFICER/DIRECTOR OF EMERGENCY SERVICES DECLARES AND PROCLAIMS as follows:

- 1. Conditions of extreme peril to the safety of persons and property have arisen within Napa County as of 3:20 a.m. on August 24, 2014 due to earthquake and
- 2. In consequence of said conditions and pursuant to Government Code section 8630 and Napa County Code section 2.80.060(A)(2), a local emergency now exists throughout Napa County.
- 3. During this local emergency the powers, functions, and duties of the Napa County Executive Officer and the emergency organization of Napa County shall be those prescribed by State law, and the ordinances, resolutions, and approved emergency services plans of the County of Napa.

4. Specific Orders.

In connection with the foregoing proclamation and order of local emergency, the Napa County Executive Officer also orders as follows, for the protection of life and property:

- a. The following public facilities are closed to use by all but emergency personnel until further notice: County Administrative Building (1195 Third Street), Carither's Building (entire building on First Street and Parkway Mall), and the building located at 650 Imperial Way, Napa, CA.
- 5. This proclamation of local emergency shall be reviewed by the Board of Supervisors within seven days and if not confirmed and ratified by the Board of Supervisors

shall expire on the seventh day or such earlier date as specified by the Board of Supervisors.

6. This proclamation and the contents thereof shall be published and promulgated in as widespread a manner as reasonably feasible in light of the conditions prevailing during the local emergency.
