Napa County Probation STAR Program Annual Report- 2013-2014

The STAR (Success through Acting Responsibly) program is a delinquency intervention program of the Napa County Probation Department. The purpose of the program is to increase the competencies of juvenile probationers and their families so that youth successfully complete probation, do not re-offend and they attempt to repair the harm they might have done to a victim. The program is staffed with two Deputy Probation Officers who are responsible for supervising youth on this caseload and to coordinate with Probation and staff from other community based agencies to provide STAR program services.

Program Services

There are several programs available to youth participating in the STAR program. Referrals for programs and services are made by probation officers who supervise juvenile offender caseloads. The program services youth receive are a function of the Youth Level of Service/Case Management Inventory (YLS-CMI). The YLS-CMI is a validated assessment tool that assists probation officers to identify

The YLS-CMI is a validated assessment tool that assists probation officers to identify risk, responsivity and the top criminogenic needs in order to create more meaningful case plan objectives for all juvenile offenders. Assessments are reviewed as youth progress through their probation periods and their risk levels are adjusted according to the level of need.

The Napa County Probation Department continues to provide ongoing Evidence Based Practices (EBP) training and refreshers trainings including: The Carey Guides (an effective case management tool utilized to assist Probation Officers in obtaining a balance in their approach with offenders and in helping the offender identify meaningful rewards while linking those rewards with positive behavior change) and Motivational Interviewing (MI).

Over the last year, the Juvenile Division has provided ongoing cognitive behavior groups, to 128 probation youth. 119 youth successfully completed groups which included 1021 program days. Cognitive behavior groups continue to be offered to youth at school sites and at the probation department. These groups provide practical applications for skill building in the areas of values, attitudes, beliefs, decision making and relationship building.

The following services are available to youth in custody; although some may also be offered to youth who are not in custody

- The YLS/CMI is administered by a probation officers to each youth placed on probation.
- The Massachusetts Youth Screening Instrument (MAYSI) an initial mental health and substance abuse screening tool is administered by the
 Juvenile Hall Forensic Mental Health Counselor to all detainees soon after they are admitted into Juvenile Hall.
- Gang Awareness programming, utilizing the EBP Carey Guides, is offered to youth in custody who have been identified as having gang association.
- Thinking For A Change (TFC) is an EBP program and is provided to youth in and out of custody.
- Life Skills Training is an Evidence Based Program offered through National Curriculum Training Institute (NCTI) and offered to youth in Juvenile Hall and also utilizes the Carey Guides.
- Living In Balance, a cognitive behavioral evidenced based drug and alcohol program, is brief intervention substance abuse treatment which is provided weekly to youth in custody by a Wolfe Center counselor. It is designed to enhance proactive choices and move toward reducing known risk factors. Additionally, youth in custody are administered the American Association of Addiction Medicine (ASAM) which is a substance abuse early intervention and pre-assessment tool.
- Aggression Replacement Training, (ART) gender specific Evidence Based Programming, is offered to youth in and out of custody.
- · Anger Management, an Evidence Based Program offered through National Curriculum Training Institute (NCTI) is offered to youth in Juvenile Hall.

Performance Data

Last year the program served 128 youth. Of those youth, 119 completed the program and 9 did not complete the program. The number of youth who completed programming is slightly higher than the last reporting period.

Mandated Outcomes

The program's mandated outcomes focus on six areas: arrest rates, incarceration rates; probation violation rates; rates for completion of probation, rates for completion of community work service, and rates of completion of restitution payment. Outcomes for 2013-2014 will include program participants who completed their outcome period.

Arrests: There was an average of 2.77 arrests per participant twelve months prior to services (this includes both new offenses and violations of probation). On average, there were 2.18 arrests twelve months post services.

Incarceration: The incarceration rate of the participants twelve months prior to services was 2.77. On average, this figure dropped to 2.18 post services.

Probation Violations: The probation violation rate for program youth averaged 1.98 pre-program services and 1.98 for post-program services youth.

The following reference groups consist of youth similar to the youth who participated in the STAR program and did not meet the criteria to receive STAR program services.

Completion of Probation: On average 15.83% of program youth completed probation within twelve months of program entry. One of the 30 participants in the reference group completed probation.

Community Service: This year, 19 of the 104 youth who received program services completed their community service hours. 18.27 % of the youth completed Community Service hours within the reporting period. In the reference group, of the 28 youth who were ordered Community Service, 2 completed their hours.

Restitution: For those in the program, 8.70 % completed their restitution payments. For participants in the reference group, of the 21 who were ordered restitution, 3 participants completed restitution.

Implementation Challenges

The Napa County Probation Department continues to offer a variety of cognitive behavior groups focused on delivering EBP programming to targeted youth. However, it remains clear that the population of juvenile offenders continues to remain low nationally and fewer youth are on probation; therefore, the number of youth completing program services continues to be low.

Overall Program

The Napa County Probation Department Juvenile Probation continues to provide of EBP programming to Probation youth thereby decreasing recidivism as well as the population in juvenile hall and those sent to residential treatment facilities. Therefore, each year the outcomes for the STAR program are varying depending on changes in programming and the population being served throughout the year.

In this last rating period, outcomes were measured based on a 365 day rating period. Overall, there was a slight increase in the number of probation youth served in the STAR program. The Violation of Probation (VOP) rate pre programming has decreased due, in part to the fact that Probation has begun to identify and expand options for alternate responses to violation behavior.

Although the percentage of youth who completed probation in this rating period has decreased slightly, it is important to note that over the last four years there has been a 56% reduction in the number of youth on probation. There has been a consistent and overall reduction in the juvenile hall population during the last reporting period and this pattern appears to be holding.

Juvenile Probation caseloads are currently in line with the EBP caseloads standards. The number of cognitive behavior groups has increased thereby offering more dosage hours to youth as part of their probation case plan. Additionally, the fact that the total number of youth on probation continues to be down from last year seems to be an indication that the implementation of EBP practices is having a positive impact on the overall goal of this department to reduce recidivism.
