Speed Limit Evaluation

A posted speed limit is required to be at the 5-mph increment nearest to the measured prevailing speed. It may be lowered by 5 mph if the Engineering & Traffic Survey documents in writing the conditions and justification for the lower speed limit.

The speed limit on Atlas Peak Road is evaluated as follows:

Based on prevailing speeds alone, the data indicates that it would be appropriate to post a speed limit as follows:

In cases in which the speed limit needs to be rounded up to the nearest five miles per hour increment of the 85th-percentile speed, the local authority may decide instead to round down, but then shall not reduce the speed limit any further for any reason.

Summary of Findings

Speed limit will be posted on Atlas Peak Road as follows, and will be eligible for radar enforcement under the provisions of Section 40802 of the California Vehicle Code.
