Table A provides a listing of donations known to be received by Napa County Departments from January 1, 2018 to March 31, 2018. The information is based on an analysis of the general ledger, Board actions, and notifications sent to the Auditor-Controller's Office.

The amount reportable to the Auditor-Controller's Office for the quarter ending March 31, 2018 is \$8,141.21. Of the reportable amount \$2,000 in cash donations was deposited into the County Treasury by the Animal Shelter prior to the Auditor-Controller's acceptance. Non-cash donations related to the Napa Complex Fire worth \$200 under Non-Departmental Revenue were also accepted prior to the Auditor-Controllers approval.

In accordance with separate Board Resolutions, the total amount accepted by departments is \$26,747.08 of which \$895 have no reporting requirements. The amount to be reported by various Napa County Departments is \$9,322.84 and the amount already reported to the Board of Supervisors directly by the Animal Shelter is \$26,717.08.

The total amount of donations received by the County from January 1, 2018 to March 31, 2018 is \$34,858.29. See Table A for additional detail.
