Please explain your reasons for wishing to serve and, in your opinion, how you feel you could contribute.\*

I am applying to serve on the Napa County Arts and Culture Advisory Committee, specifically for the vacant Education of Arts and Culture committee member seat.

I offer over 18 years of experience working in art education at the college level. The positions I've held provided me with knowledge in many aspects of the student lifecycle.

#### Recruitment and Admissions Processes

I began my career recruiting talented young artists enrolled in high schools by visiting specialized art programs and public schools in urban areas on the east coast. I also had the pleasure of recommending students for merit scholarships during the admission process of which I also worked with community college faculty to name promising students for transfer scholarships. During this time of my career, I taught courses to pre-college students, college freshman and graduate studio art students. Being a graduate of two Bay Area arts schools, San Francisco Art Institute and California College of the Arts, it was a natural for me to share first-hand knowledge with my students in the classroom and in my job.

#### Enrollment Management and Academic Administration

Over the past 10 years, I've been honored to work predominantly in enrollment management and academic administration. This work allows me to put strategies in place to monitor student success and create sustainable retention efforts.

My current role as interim Dean of Arts and Humanities at Napa Valley College has been extremely rewarding. We are actively focused on our programs and where we can best serve the community. The areas where we've seen success are in dual enrollment with Napa Unified School District (NVUSD) high schools by offering courses in subjects such as Art History, Humanities, Digital Arts & Design and online Photography classes. We've also authored new noncredit courses for older adults in music, theater and visual arts.

## Local Volunteer Positions and the Future

Since becoming a resident of Napa County nearly five years ago, I have served on the Arts Council Napa Valley Board of Director's. My term is coming to an end in June 2019. During my tenure, I participated in the shaping of ACNV's re-granting program while I was Chair of the Organizational Sustainability Committee. We worked closely with Olivia Dodd to set criteria, consider eligibility requirements and suggest an application process that would be non-prohibitive. We continue to review the re-granting processes and make board appropriate recommendations. I've been peripherally involved in our signature Arts Education Master Plan by participating in discussions with the community and NVUSD. As a Board of Director, I was an active witness in the development of the plan and continue to monitor funding associated to our success.

It would be my pleasure to serve on the Napa County Arts and Culture Advisory Committee. I am passionate about civic volunteerism and realize there is so much that we can accomplish together. I believe I can make a positive contribution at such an exiting time in Napa. Residents continue to see growth and opportunities for the arts come as the City develops. I'd like to be part of this work in the next year.

Napa Valley College (2014–present) Napa Valley College is a comprehensive, nonresidential, two-year public institution of higher education serving over 16,500 students with two campuses in Napa and St. Helena California. The college offers premier programs of study including degrees and certificates.

Interim Dean, Arts and Humanities - (2017-present) The Division of Arts and Humanities includes degree programs in Studio Arts, Art History, Digital Arts & Design, Film Studies, Humanities, Music (vocal and instrumental), Musical Theater, Philosophy, Photography and Theater. The Associate Dean is a direct report to the Vice President of Academic Affairs and supervises full-time classified staff and part-time hourly employees. Responsibilities include planning and implementation of strategic vision for the Center in collaboration with the College offices at all levels.
