Background Summary

I have been a practicing lawyer since 1971, admitted to practice in California, Arizona and the District of Columbia. I am now semi-retired, continuing to work on several matters of particular interest but able to devote the bulk of my time to other activities.

We have owned our house in Yountville, and have been regular Napa visitors since 2003. When I scaled back my legal work, my wife Mary and I moved to Northern California to live full time, and Yountiville is our permanent residence. We have three grown daughters, two of whom live in Napa with their families.
