## **RESOLUTION NO. 2019-35**

## RESOLUTION OF THE NAPA COUNTY BOARD OF SUPERVISORS TEMPORARILY CLOSING A PORTION OF COOMBSVILLE ROAD TO THIRD AVENUE AT NORTH AVENUE

WHEREAS, Section 21101 of the California Vehicle Code allows local authorities to adopt rules and regulations by resolution to provide for temporarily closing a portion of any street or road for celebrations, parades, local special events, and other purposes when, in their opinion, the closing is necessary for the safety and protection of persons who are to use that portion of the street or road during the temporary closing; and

**WHEREAS,** the sponsor, Premier Event Management, LLC ("Permittee"), of the "Napa Women's Half Marathon and 5K" has requested a special events permit for a race to be held on Sunday, March 24, 2019 between the hours of 7:00 A.M. and 9:30 A.M.; and

WHEREAS, Permittee has requested in its special events permit application the temporary closure of the county portions of Coombsville Road east of Silverado Middle School to Third Avenue at North Avenue;

**NOW, THEREFORE, BE IT RESOLVED** by the Napa County Board of Supervisors pursuant to Section 21101 of the California Vehicle Code that the Board hereby permits the temporary closure from Coombsville Road east of Silverado Middle School to Third Avenue at North Avenue on Sunday, March 24, 2019 from 7:00 A.M. to 9:30 A.M. to provide during that period for the safety and protection of persons using those portions of such County roads during the "Napa Women's Half Marathon & 5K" special event, subject to the following conditions:

- 1. Permittee will furnish to the County a Certificate of Insurance in the amount of \$1,000,000 with an endorsement naming Napa County and its officers, employees, agents, and volunteers as additional insureds;
- 2. Traffic control measures including but not limited to signs, barricades and cones shall be used as directed by traffic control personnel and be in accordance with the requirements of the State of California, Department of Transportation, Traffic Manual and as approved by Napa County, both as to type and location;
- 3. Permittee shall have entered into a contract with the California Highway Patrol for traffic control services during the event;
- 4. The owners and occupants of all properties having access to the portions of Coombsville Road and Third Avenue being closed shall be notified by Permittee or their representative prior to the event and access shall be provided to them during the event;
- 5. Access and through travel, if necessary, shall be provided for emergency vehicles at all times; and

6. All clean-up and repair of any damage done to County-owned facilities as a result of this event shall be done by the Permittee at Permittee's expense.


