NAPA COUNTY RESOLUTION NO. 2019-41

RATIFICATION AND CONTINUANCE OF PROCLAMATION OF LOCAL EMERGENCY

WHEREAS, Government Code section 8630 and Napa County Code section 2.80.060(A)(2) authorize and empower the Napa County Executive Officer acting as the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when the County is affected or likely to be affected by a public calamity and the Board is not in session, subject to confirmation by the Board within seven days; and

WHEREAS, on March 6, 2019, and pursuant to the foregoing provisions, the Napa County Executive Officer proclaimed the existence of a local emergency due to significant rainfall that resulted in localized flooding, landslides, damage to public infrastructure, and road closures resulting in a condition of extreme peril to life and property as of February 26, 2019 by that proclamation attached hereto as Exhibit "A" and incorporated by reference herein; and

WHEREAS, the Napa County Executive Officer has informed the Board that there continues to exist within Napa County a condition of extreme peril to life and property due to the ongoing impacts of the aforementioned storm events and has requested that the Board confirm the proclamation and further proclaim that a local emergency continues to exist;

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. The Board of Supervisors hereby confirms the finding of the Napa County Executive Officer that conditions of extreme peril to the safety of persons and property arose within Napa County on or about 4:30 P.M. on February 26, 2019 due to the aforementioned storm events, that such conditions continue to exist, and that such conditions warranted and continue to warrant a proclamation of local emergency.
- 2. The Board of Supervisors hereby confirms and ratifies the proclamation and orders of the Director of Emergency Services that a local emergency existed throughout Napa County, as set forth in Exhibit "A".
- 3. The Board of Supervisors further proclaims and orders that such local emergency continues to exist and that the orders previously instituted by the Napa County Executive Officer as the Director of Emergency Services as stated in Exhibit "A" shall remain in place as orders of the Board of Supervisors.
- 4. The Board of Supervisors hereby also proclaims and orders that until the local emergency is terminated the powers, functions, and duties of the Napa County Executive Officer/Director of Emergency Services and the emergency organization of Napa County shall be those prescribed by State law and the ordinances, resolutions, and approved emergency services plans of Napa County.

- 5. The Napa County Executive Officer or designee is hereby ordered and directed to give this Resolution and the proclamations and orders contained therein widespread publicity and notice.
- 6. This confirmation and continuance of the proclamation of local emergency shall be reviewed by the Board of Supervisors at a regular meeting of the Board at least every 30 days until terminated, to determine the need for continuing the local emergency, and termination of the local emergency shall be proclaimed by this Board at the earliest possible date that conditions warrant.
- 7. The Board hereby increases appropriations for fiscal year 2018-19 by two million five hundred thousand dollars (\$2,500,000) for the purpose of response and recovery to the 2019 Winter Storms and authorizes the Auditor-Controller to increase individual budget units as necessary, offset by the use of the General Fund General Reserve.

PROCLAMATION OF LOCAL EMERGENCY

PROCLAMATION OF LOCAL EMERGENCY

WHEREAS, Government Code section 8630 and Napa County Code section 2.80.060(A)(2) authorize and empower the Napa County Executive Officer/Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when the County is affected or likely to be affected by a public calamity and the Board of Supervisors is not then in session, subject to confirmation by the Board of Supervisors within seven days thereafter; and

WHEREAS, the County Executive Officer/Director of Emergency Services by delegation has found that due to significant rainfall that resulted in localized flooding, landslides, and road closures, a condition of extreme peril to life and property now exists in Napa County; and

WHEREAS, such conditions of extreme peril began on February 26, 2019 at approximately 4:30 PM; and

WHEREAS, the Board of Supervisors is not presently in session;

NOW, THEREFORE, THE NAPA COUNTY EXECUTIVE OFFICER/DIRECTOR OF EMERGENCY SERVICES DECLARES AND PROCLAIMS as follows:

- 1. Conditions of extreme peril to the safety of persons and property have arisen within Napa County as of February 26, 2019 at approximately 4:30 PM due to heavy rains, saturated ground, and high tides which have toppled trees, washed out county roads, washed out creek banks endangering public infrastructure, and other damage and impacts; and
- 2. In consequence of said conditions and pursuant to Government Code section 8630 and Napa County Code section 2.80.060(A)(2), a local emergency now exists throughout Napa County.
- 3. During this local emergency the powers, functions, and duties of the Napa County Executive Officer and the emergency organization of Napa County shall be those prescribed by State law, and the ordinances, resolutions, and approved emergency services plans of the County of Napa.
- 4. This proclamation of local emergency shall be reviewed by the Board of Supervisors within seven days and if not confirmed and ratified by the Board of Supervisors shall expire on the seventh day or such earlier date as specified by the Board of Supervisors.
- 5. This proclamation and the contents thereof shall be published and promulgated in as widespread a manner as reasonably feasible in light of the conditions prevailing during the local emergency.
