Applicant, Raconteur Fine Wines LLC, currently leases a 6215 sq ft space from Alexis Court I LLC at 521 Alexis Court in the county of Napa and operates under a Type 20 ABC license, allowing off-sale wine sales. The space serves as the primary location of storage and shipping point of bottled wine.

Current Business Model: Off-site retail sales of premium wine to individuals and corporations (Type 20 ABC license which allows beer & wine sales). The firm's main focus is filling wine cellars with mature, rare, and highly allocated wines from the top, global winegrowing regions and producers; the firm also occasionally organizes wine tastings and gifting programs for corporate clientele (all off-site).

Desired change: Upgrade to a Type 21 license which simply allows the addition of spirits to our portfolio.

No modification to our business model or is intended; but we are willing to adhere to any conditions that the Board/Planning Dept. may want to place on this Use. We focus exclusively on rare and highly allocated wines and do not post our inventory online.
