4. LEGISLATIVE UPDATE BY FEDERAL LEGISLATIVE ADVOCATES FOR NAPA COUNTY

Steve Palmer, Van Scoyoc Associates, discussed upcoming Congressional hearings on the President's Fiscal Year 2020/2021 budget proposal.

David Haines, Van Scoyoc Associates, reported the House Energy and Commerce Committee will hold a hearing this Thursday to review eight bills ranging from addressing wireless infrastructure resiliency issues for natural disasters to suicide prevention legislation.

- 6. LEGISLATIVE UPDATE BY STATE LEGISLATIVE ADVOCATES FOR NAPA COUNTY

Karen Lange of Shaw, Yoder, Antwih, Schmelzer, & Lange, discussed upcoming bill lists, the Governor's resiliency bond and SB 45. Ms. Lange also stressed counties need to spend any Prop 63 funds that are above reserve standards by June 30 or they will be spent by the State.

Paul Yoder of Shaw, Yoder, Antwih, Schmelzer, & Lange, discussed the Governor's new homelessness plan.

A. County Executive Officer, on behalf of Senator Bill Dodd, requests discussion and possible action on SB 884 (Dodd) which would establish a voluntary Disaster Relief Instructional Recovery Program for school districts that lose five or more days because of a PSPS and adds PSPS to the list of eligible emergencies that are exempt from the State's requirements to maintain at least 175 days of regular school days when determining funding allocations.

Unanimous vote to approve.

7. CONSIDERATION OF STATE LEGISLATION/ISSUES

A. Director of Public Works requests discussion and possible action on Governor Newsom's proposal to appropriate \$50 million for animal shelter grants in the 2020-2021 State budget. **Item dropped.**
