In closed session today, in the context of discussing anticipated litigation on this subject, the Board, by unanimous vote, determined that Argonaut Construction is in breach of the May 1, 2014 Contract for

construction of the Devlin Road Transfer Station Pavement Rehabilitation – Phase I Project, and, unless an acceptable resolution is reached with Argonaut by April 17, 2015, directed staff to give Argonaut Constructors notice of such breach, notice of termination of the Contract, and notice that the Authority will withhold the retention amount up to \$45,450.52 to cover the Authority's costs to correct deficiencies in Argonaut's work, to repair damage caused to Authority facilities by Argonaut, and to complete work under the Contract that Argonaut has failed to complete despite demand to do so from the Authority.
