

**ORDINANCE NO. \_\_\_\_\_**

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE  
COUNTY OF NAPA, STATE OF CALIFORNIA, REZONING A  
CERTAIN PARCEL WITHIN THE UNINCORPORATED AREA OF  
THE COUNTY FROM AN AGRICULTURAL WATERSHED (AW) TO  
AN AGRICULTURAL PRESERVE (AP) ZONING DISTRICT  
(GORDON FAMILY RANCH, APN 033-220-002)**

The Board of Supervisors of the County of Napa ordain as follows:

SECTION 1. The 256.7 acre parcel located east of Gordon Valley Road, at its intersection with Grapevine Lane, Assessor's parcel number 033-220-002, as identified in the Official Maps of the Napa County Assessor in effect at the time this Ordinance takes effect and as shown on Exhibit "A" attached and incorporated here by reference is hereby rezoned from AW (Agricultural Watershed) to AP (Agricultural Preserve).

SECTION 2. The parcel is designated Agricultural Resource on the County's General Plan Land Use Map. This Ordinance rezoning the parcel from AW to AP is consistent with the Napa County General Plan (2008) in that General Plan Policy Ag/LU-114 and implementing Table Ag/LU-B identify AP "as the appropriate zoning designation" for lands designated Agricultural Resource on the General Plan Land Use Map.

SECTION 3. This Ordinance shall take effect thirty (30) days after its passage.

SECTION 4. This Ordinance shall be published at least once before the expiration of fifteen (15) days after its passage in the Napa Register, a newspaper of general circulation published in the County of Napa, together with the names of the members voting for and against the same.
