WATER AVAILABILITY ANALYSIS

PHASE 1 STUDY

<u>Introduction:</u> As an applicant for a permit with Napa County, It has been determined that Chapter 13.15 of the Napa County Code is applicable to approval of your permit. One step of the permit process is to adequately evaluate the amount of water your project will use and the potential impact your application might have on the static groundwater levels within your neighborhood. The public works department requires that a Phase 1 Water Availability Analysis (WAA) be included with your application. The purpose of this form is to assist you in the preparation of this analysis. You may present the analysis in an alternative form so long as it substantially includes the information required below. Please include any calculations you may have to support your estimates.

The reason for the WAA is for you, the applicant, to inform us, to the best of your ability, what changes in water use will occur on your property as a result of an approval of your permit application. By examining the attached guidelines and filling in the blanks, you will provide the information we require to evaluate potential impacts to static water levels of neighboring wells.

Step #1:

Provide a map and site plan of your parcel(s). The map should be an 8-1/2"x11" reproduction of a USGS quad sheet (1:24,000 scale) with your parcel outlined on the map. Include on the map the nearest neighboring well. The site plan should be an 8-1/2"x11" site plan of your parcel(s) with the locations of all structures, gardens, vineyards, etc in which well water will be used. If more than one water source is available, indicate the interconnecting piping from the subject well to the areas of use. Attach these two sheets to your application. If multiple parcels are involved, clearly show the parcels from which the fair share calculation will be based and properly identify the assessors parcel numbers for these parcels. Identify all existing or proposed wells.

Step #2: Determine total parcel acreage and water allotment factor. If your project spans multiple parcels, please fill a separate form for each parcel.

Determine the allowable water allotment for your parcels:

Parcel Location Factors

The allowable allotment of water is based on the location of your parcel. There are 3 different location classifications. Valley floor areas include all locations that are within the Napa Valley,

Pope Valley and Carneros Region, except for areas specified as groundwater deficient areas. Groundwater deficient areas are areas that have been determined by the public works department as having a history of problems with groundwater. All other areas are classified as Mountain Areas. Please circle your location classification below (Public Works can assist you in determining your classification if necessary):

^{*}Water use for vineyards should be no lower than 0.2 AF—unless irrigation records are available that show otherwise.

^{**}To determine your existing and proposed total water use in gallons, multiply the totals (in acrefeet) by 325,821 gal/AF.

Step #4:

Provide any other information that may be significant to this analysis. For example, any calculations supporting your estimates, well test information including draw down over time, historical water data, visual observations of water levels, well drilling information, changes in neighboring land uses, the usage if other water sources such as city water or reservoirs, the timing of the development, etc. Use additional sheets if necessary.

Existing Use (300,000 gallons wine/year)

Winery Process Water = 300,000 gal wine/year x 4.5 gal PW/gal wine¹ x 1 AF/325,821 gal = 4.14 AF/YR

Winery Domestic Water² (Full-time employees) = 142,350 gal SS/year x 1 AF/325,821 = 0.44 AF/YR

Winery Domestic Water² (Seasonal employees) = 5,400 gal SS/year x 1 AF/325,821 = 0.02 AF/YR

Winery Domestic Water² (Tasting visitors) = 70,200 gal SS/year x 1 AF/325,821 = 0.22 AF/YR

Winery Domestic Water² (Event visitors) = 105,000 gal SS/year x 1 AF/325,821 = 0.32 AF/YR

Winery Landscape Water³ = (300,000 gal wine/year x 0.5 AF/100,000 gal wine) - 1.0 AF/year = 0.50 AF/YR

Vineyards⁴ = 0 AF/YR

Total Winery Water Usage⁵ = 4.14 AF/YR + 1.0 AF/YR + 0.5 AF/YR = **5.64 AF/YR**

Proposed Use (429,000 gallons wine/year)

Winery Process Water = 429,000 gal wine/year x 4.5 gal PW/gal wine¹ x 1 AF/325,821 gal = 5.93 AF/YR

Winery Domestic Water² (Full-time employees) = 142,350 gal SS/year x 1 AF/325,821 = 0.44 AF/YR

Winery Domestic Water² (Seasonal employees) = 5,400 gal SS/year x 1 AF/325,821 = 0.02 AF/YR

Winery Domestic Water² (Tasting visitors) = 70,200 gal SS/year x 1 AF/325,821 = 0.22 AF/YR

Winery Domestic Water² (Event visitors) = 105,000 gal SS/year x 1 AF/325,821 = 0.32 AF/YR

Winery Landscape Water³ = $(300,000 \text{ gal wine/year} \times 0.5 \text{ AF/100,000 gal wine}) - 1.0 \text{ AF/year} = 0.50 \text{ AF/YR}$

 $Vineyards^4 = 0 AF/YR$

Total Winery Water Usage⁵ = 5.93 AF/YR + 1.0 AF/YR + 0.50 $\overline{AF/YR} = 7.43 \overline{AF/YR}$

Notes:

- 1) Winery generation rate is based on water flow data and tonnage crushed from 2011-2013.
- 2) Winery domestic water is assumed to be unchanged from the current permitted amount.
- 3) Based on Attachment A: Estimated Water Use Guidelines for Domestic/Landscaping and subtracting out winery domestic water usage. No change in landscaping is being proposed; landscape water use is not anticipated to increase with the proposed increase in wine production. Even if the larger production amount was used for landscape irrigation allowance, the projected use would remain below the threshold amount.
- 4) Vineyards are not located on the existing parcel
- 5) Water usage is currently sourced 50% from the City of St. Helena and 50% from an existing onsite well.

<u>Conclusion:</u> Congratulations! Just sign the form and you are done! Public works staff will now compare your projected future water usage with a threshold of use as determined for your parcel(s) size, location, topography, rainfall, soil types, historical water data for your area, and other hydrogeologic information. They will use the above information to evaluate if your proposed project will have a detrimental effect on groundwater levels and/or neighboring well levels. Should

Attachment A: Estimated Water Use Guidelines

Typical Water Use Guidelines:

Primary Residence 0.5 to 0.75 acre-feet per year (includes some landscaping)

Secondary Residence 0.20 to 0.30 acre-feet per year

Farm Labor Dwelling 0.06 to 0.10 acre-feet per person per year

Non-Residential Guidelines:

Agricultural:

Vineyards

Irrigation only

0.2 to 0.5 acre-feet per acre per year

Heat Protection

0.25 acre feet per acre per year

Frost Protection

0.25 acre feet per acre per year

Farm Labor Dwelling 0.06 to 0.10 acre-feet per person per year

Irrigated Pasture 4.0 acre-feet per acre per year Orchards 4.0 acre-feet per acre per year Livestock (sheep or cows) 0.01 acre-feet per acre per year

Winery:
