Dear Chair Phillips:

We are the neighbors of the proposed Dakata Shy Winery and operate Rutherford Ranch Winery. We have reviewed the staff report and while we support the expansion of the existing 1,000-gallon winery, we object to the issuance of a variance to facilitate that expansion.

We think the rationale that staff has provided to recommend the issuance of a variance is inconsistent with the required findings and the recently adopted APAC/Planning Commission. The Board of Supervisors at its December 8, 2015 meeting also endorsed these recommendations. This recommendation directs the Commission to "avoid the use of variances as a principle tool for achieving compliance with land use regulations. Variances may be used only when there is specific evidence supporting **all** [emphasis added] necessary findings. Any new addition could and should be attached to the existing winery in such a way as to obviate the need for a variance as allowed by the zoning code. There is no physical barrier to doing so. Neither the staff nor the applicant has presented any evidence to the contrary.

Access to the proposed winery is also problematic. While the desire of the applicant is to have frontage on Silverado Trail, getting to the winery requires a convoluted route. The extensive internal circulation system results in excess hardscape, with increased coverage of agricultural land, storm water runoff and potential sedimentation. The only apparent reason for this circuitous circulation is to avoid a left turn lane on Silverado Trail that is required for projects that generate more than 20 daily trips. The circulation system appears to be designed not for efficient access but to avoid a left turn lane.

## Recommendation

We are winery owners and do not object to the development or reasonable expansion of existing wineries. What we do object to is the issuance of a variance when options for property improvement without a variance are available.
