Hello, my name is Keith Lindstrom and I live at 275 Casswall St, which is near Truchard Family Winery.

I wish to encourage the commission to approve the Truchard use permit and to allow the construction project for their winery. 



Increasingly, Napa County is faced with decisions about what growth should be allowed and if this growth is consistent with the values and identity that has been established for our valley.

This identity was solidified in 1968 when Napa's residents and government worked together to create America's first agricultural land preserve. It was a remarkable accomplishment. The legislation served not just to preserve rural land and limit development, but to clearly define Napa's vision for its future, an agricultural future. At that time farmland here was more dedicated to sheep and cattle, but its protected status allowed the transition to vineyards and produced one California's most famous landmarks, and most popular tourist destinations. Wineries associated with these vineyards have become not just a place to process grapes, but a place for people to visit and to buy wine in what is perhaps farming's best example of agritourism.

This success has come at the cost of increased traffic, and despite the obvious contributions that wineries have made to the quality of life here, some question whether this is the kind of growth that we want. Today, our Supervisors and Planning Commissioners speak openly of limiting visitors to wineries, but encourage rapid residential development within the city limits and promote events like rock concerts, golf tournaments, and film festivals that bring hundreds of thousands to Napa each year. At times, it seems that they have lost sight of the vision that they have been entrusted to protect.

The Truchard Winery represents the best of Napa's history and future. In the ever more corporate and global wine industry, it is one of the increasingly rare examples of Napa's family farming and winemaking roots.
