I. Executive Summary

O'Brien Winery has an approved Use Permit allowing wine production up to 20,000 gallons per year and is requesting recognition and authorization of existing visitation, employees and marketing events. Below is a summary of the water use. Detailed calculations can be found on the next page. A Groundwater recharge rate of 1.0 af/yr/acre for valley floor was adopted for the 26.93 acre parcel to give a total groundwater recharge of 26.93 af/yr for the project parcel.
