1. SCOPE

This Use Permit Major Modification approves modification of Use Permit # 01074-UP to allow:

- An increase in annual production from 20,000 gallons/year to 50,000 gallons/year;
- Construction of a new 3,500 square foot barrel storage building with approximately 1,360 square feet of covered walkway on three sides;
- Addition of 699 square feet of covered crush pad area;
- Expansion of the marketing plan by adding daily wine and food pairings (catered food only) and new monthly marketing events with 75 people, as amended and described below in the Visitation, Tours and Tasting, and Marketing Plan;
- On-premise wine consumption consistent with Assembly Bill 2004 (Evans) outside the winery building entrance;
- Project phasing in two phases to allow; 1) the new barrel storage building to proceed immediately following Use Permit Modification approval with no increase in production to take place until the building is completed; and 2) required access road widening and installation of expanded waste-water treatment and processing facilities for increased production to be completed prior to issuance of a Certificate of Occupancy for the new barrel storage building.
- Hours of operation for the winery shall be limited to 7:00 AM to 5:00 PM (except during crush);
- Two full-time and two part-time employees; and
- Nine on-site parking spaces.

The winery shall be designed in substantial conformance with the submitted site plan, elevation drawings, and other submittal materials and shall comply with all requirements of the Napa County Code. It is the responsibility of the permittee to communicate the requirements of these conditions and mitigations (if any) to all designers, contractors, employees, and guests of the winery to ensure compliance is achieved. Any expansion or changes in use shall be by the approved in accordance with Section 18.124.130 of the Napa County Code and may be subject to the Use Permit modification process.

2. PROJECT SPECIFIC CONDITIONS

- A. Landscape screening shall be provided along both the east and south sides of the new barrel storage building, in addition to that shown on attached Sheet # L-10, Existing and Proposed Landscape Plan, Jerry Gregori Architect (refer to Condition # 9).
- B. Tours and tastings shall not occur on the same day as marketing events.

3. COMPLIANCE WITH OTHER DEPARTMENTS AND AGENCIES

Project conditions of approval include all of the following County Department and Agency requirements. The permittee shall comply with all applicable building codes, zoning standards, and requirements of County Departments and Agencies at time of submittal and may be subject to change, including but not limited to:

- A. Department of Environmental Management as stated in their letter of January 11, 2012 (attached as pages 11-12);
- B. Department of Public Works as stated in their letter of July 12, 2011 and February 7, 2012 (attached as pages 13-17);
- C. County Fire Marshal as stated in their letter of June 27, 2011 (attached as pages 18-20);
- D. City of Calistoga as stated in their letter of August 21, 2009 (attached as page 21).

The determination as to whether or not the permittee has substantially complied with the requirements of other County Departments and Agencies shall be determined by those Departments or Agencies. The inability to substantially comply with the requirements of other County Departments and Agencies may result in the need to modify the approved use permit.

4. **VISITATION**

Consistent with Sections 18.16.030 and 18.20.030 of the Napa County Code, marketing and tours and tastings may occur at a winery only where such activities are accessory and "clearly incidental, related, and subordinate to the primary operation of the winery as a production facility."

Permittee shall obtain and maintain all permits and licenses from the California Department of Alcoholic Beverage Control (ABC) and United States Tax and Trade Bureau (TTB) required to produce and sell wine, including minimum levels of crush and fermentation. In the event permittee loses required ABC and/or TTB permits and licenses, permittee shall cease marketing events and tours and tastings until such time as those ABC and/or TTB permits and licenses are re-established.

A log book (or similar record) shall be maintained which documents the number of visitors to the winery (be they tours and tastings or marketing event visitors), and the dates of their visit. This record of visitors shall be made available to the Department upon request.

A. TOURS AND TASTING

Exhibit B – Conditions of Approval Envy Wines, LLC / Marc Carter Page 2 of 10 Tours and tastings are limited to the following:

<u>Frequency:</u> Seven days per week, Monday - Sunday, by appointment only <u>Maximum number of persons per day:</u> Eight (8) <u>Maximum number of persons per week:</u> Fifty-six (56) <u>Time of operation:</u> 10:00 AM - 5:00 PM, Daily

"Tours and tastings" means tours of the winery and/or tastings of wine, where such tours and tastings are limited to persons who have made unsolicited prior appointment for tours or tastings. Tours and tastings may include food and wine pairings, where all such food service is provided without charge except to the extent of cost recovery and is incidental to the tasting of wine. Food service may not involve menu options and meal service such that the winery functions as a café or restaurant. (Ord 1340 §2, Sec. 18.08.062)

Start and finish time of tours and tastings shall be scheduled to minimize vehicles arriving or leaving between 4:00 PM and 6:00 PM, and shall be limited to those wines set forth in Napa County Code Sec. 18.16.030(G)(5)(c).

B. MARKETING

Marketing events are limited to the following:

c.	<u>Type of Event:</u> <u>Frequency:</u> <u>Number of persons:</u> <u>Time of Day:</u>	Private Promotional Tastings and Meals (medium event) 12 times per year (monthly) 75 maximum 11:00 AM to 10:00 PM
d.	<u>Type of Event:</u> <u>Frequency:</u> <u>Number of persons:</u> <u>Time of Day:</u>	Release Events 2 times per year 100 maximum 11:00 AM to 10:00 PM

e. Participation in Auction Napa Valley.

"Marketing of wine" means any activity of a winery which is conducted at the winery on a prearranged basis for the education and development of customers and potential customers with respect to wine which can be sold at the winery on a retail basis pursuant to Chapters 18.16 and 18.20 of the Napa County Code. Marketing of wine may include cultural and social events directly related to the education and development of customers and potential customers provided such events are clearly incidental, related and subordinate to the primary use of the winery. Marketing of wine may include food service, including food and wine pairings, where all such food service is provided without charge except to the extent of cost recovery.

Business events are similar to cultural and social events, in that they will only be considered as "marketing of wine" if they are directly related to the education and development of customers and potential customers of the winery and are part of a marketing plan approved as part of the winery's use permit. Marketing plans in their totality must remain "clearly incidental, related and subordinate to the primary operation of the winery as a production facility" (subsection (G)(5) of Sections 18.16.030 and subsection (I)(5) of 18.20.030 of the Napa County Code). To be considered directly related to the education and development of customers or potential customers of the winery, business events must be conducted at no charge except to the extent of recovery of variable costs, and any business content unrelated to wine must be limited. Careful consideration shall be given to the intensity of the overall marketing plan. (Ord. 1340, 2010: Ord. 1104 § 11, 1996: Ord. 947 § 9 (part), 1990: prior code § 12071).

All activity, including cleanup, shall cease by 10:00 PM. Start and finish time of activities shall be scheduled to minimize vehicles arriving or leaving between 4:00 PM and 6:00 PM. If any event is held which will exceed the available on-site parking, the applicant shall have prepare an event specific parking plan which may include but not be limited to valet service or off-site parking and shuttle service to the winery.

5. GRAPE SOURCE

At least 75% of the grapes used to make the winery's wine shall be grown within the County of Napa. The permittee shall keep records of annual production documenting the source of grapes to verify that 75% of the production is from Napa County grapes. The report shall recognize the Agriculture Commission's format for County of origin of grapes and juice used in the Winery Production Process. The report shall be provided to the Conservation, Development and Planning Department upon request, but shall be considered proprietary information not available to the public.

6. **RENTAL/LEASING**

No winery facilities, nor portions thereof, including but not limited to offices, kitchens, barrel storage areas, and warehousing space, shall be rented, leased, nor used by entities other than persons producing and/or storing wine at the on-site winery, such as alternating proprietors and custom producers, except as may be specifically authorized in this use permit or pursuant to the Temporary Events Ordinance (Chapter 5.36).

7. SIGNS

Prior to installation of any winery identification or directional signs, detailed site plans and sign design plans, including locations, elevations, materials, color, and lighting, shall be submitted to the Planning Department for administrative review and approval. Administrative review and approval is not required if signage to be installed is consistent with signage plans submitted, reviewed and approved as part of this use permit approval. All signs shall meet the design standards as set forth in Chapter 18.116 of the County Code. At least one sign placed and sized in a manner to inform the public must legibly and visibly include wording stating "Tours and Tasting by Prior Appointment Only".

8. LIGHTING

All exterior lighting, including landscape lighting, shall be shielded and directed downward, shall be located as low to the ground as possible, and shall be the minimum necessary for security, safety, or operations and shall incorporate the use of motion detection sensors to the greatest extent practical. No flood-lighting or sodium lighting of the building is permitted, including architectural highlighting and spotting. Low-level lighting shall be utilized in parking areas as opposed to elevated high-intensity light standards. Prior to issuance of any building permit for construction of the winery, two (2) copies of a detailed lighting plan showing the location and specifications for all lighting fixtures to be installed on the property shall be submitted for Department review and approval. All lighting shall comply with Uniform Building Code (UBC).

9. LANDSCAPING

Two (2) copies of a detailed landscaping and irrigation plan, including parking details, shall be submitted for review and approval prior to issuance of building permits. The plan shall be prepared pursuant to the County's Water Efficient Landscape Ordinance (WELO), as applicable, and shall indicate the names and location of all plant materials to be used along with the method of maintenance.

<u>Plant materials shall be purchased locally when practical. The Agricultural Commissioner's</u> office (707-253-4357) shall be notified of all impending deliveries of live plants with points of origin outside of Napa County.

No trees greater than 6" diameter at breast height shall be removed, except for those identified on the submitted site plan. Trees to be retained shall be protected during construction by fencing securely installed at the outer most dripline of the tree or trees. Such fencing shall be maintained throughout the duration of the work undertaken in connection with the winery development/construction. In no case shall construction material, debris or vehicles be stored in the fenced tree protection area.

Evergreen screening shall be installed between the industrial portions of the operation (e.g. tanks, crushing area, parking area, etc.) and off-site residences that can view these areas.

Landscaping shall be completed prior to final occupancy, and shall be permanently maintained in accordance with the landscaping plan.

10. OUTDOOR STORAGE/SCREENING/UTILITIES

All outdoor storage of winery equipment shall be screened from the view of adjacent properties by a visual barrier consisting of fencing or dense landscaping. No item in storage is to exceed the height of the screening. Water and fuel tanks, and similar structures, shall be screened to the extent practical so as to not be visible from public roads and adjacent parcels.

New utility lines required for this project that are visible from any designated scenic transportation route (see Chapter 7 of the General Plan and Chapter 18.106 of the Napa County Zoning Ordinance for designated roads) shall be placed underground or in an equivalent manner be made virtually invisible from the subject roadway.

11. COLORS

The colors used for the roof, exterior walls and built landscaping features of the winery shall be limited to earth tones that will blend the facility into the colors of the surrounding site specific vegetation and the applicant shall obtain written approval by the Conservation, Development and Planning Department prior to painting the building. Highly reflective surfaces shall be prohibited.

12. SITE IMPROVEMENTS AND PUBLIC WORKS DEPARTMENT - Contact (707) 253-4351

A. GRADING AND SPOILS

All grading and spoils generated by construction of the project facilities, including cave spoils, shall be managed per Public Works direction. All spoils piles shall be removed prior to final occupancy.

B. TRAFFIC

Reoccurring and scheduled vehicle trips to and from the site for employees, deliveries, and visitors will not occur during peak (4:00 PM-6:00 PM) travel times to the maximum extent possible. All road improvements on private property required per the Department of Public Works shall be maintained in good working condition.

C. DUST CONTROL

Water and/or dust palliatives shall be applied in sufficient quantities during grading and other ground disturbing activities on-site to minimize the amount of dust produced. Outdoor construction activities shall not occur during windy periods.

D. STORM WATER CONTROL

The permittee shall comply with all construction and post-construction storm water pollution prevention protocols as required by County Public Works Department and the California Regional Water Quality Control Board (SRWQCB).

E. PARKING

The location of employee and visitor parking and truck loading zone areas shall be identified along with proposed circulation and traffic control signage (if any).

Parking shall be limited to approved parking spaces only and shall not occur along access or public roads or in other locations except during harvest activities and_approved marketing events. In no case shall parking impede emergency vehicle access or public roads. If any event is held which will exceed the available on-site parking, the permittee_shall prepare an event specific parking plan which may include, but not be limited to, valet service or off-site parking and shuttle service to the winery.

F. GATES/ENTRY STRUCTURES

Any gate installed at the winery entrance shall be reviewed by the Conservation, Development and Planning Department, Public Works Department and the Napa County Fire Department to assure that it is designed to allow large vehicles, such as motor homes, to turn around if the gate is closed without backing into the public roadway, and that fire suppression access is available at all times. If the gate is part of an entry structure an additional permit shall be required according to the County Code, A separate entry structure permit is not required if the entry structure is consistent with entry structure plans submitted, reviewed and approved as part of this use permit approval.

13. ENVIRONMENTAL MANAGEMENT DEPARTMENT SPECIFIC COMMENTS - Contact (707) 253-4351

A. WELLS

The permittee may be required (at the permittee's expense) to provide well monitoring data if it the Director of Environmental Management determines that water usage at the winery is affecting, or would potentially affect groundwater supplies or nearby wells. Data requested could include, but may not be limited to, water extraction volumes and static well levels. If applicant is unable to secure monitoring access to neighboring wells, onsite monitoring wells may need to be established to gage potential impacts on the groundwater resource utilized for the project proposed. Water usage shall be minimized by use of best available control technology and best water management conservation practices. In the event that changed circumstances or significant new information provide substantial evidence that the groundwater system referenced in the use permit would significantly affect the groundwater basin, the director of environmental management shall be authorized to recommend additional reasonable conditions on the permittee, or revocation of this permit, as necessary to meet the requirements of the Napa County Groundwater Ordinance and protect public heath, safety, and welfare. That recommendation shall not become final unless and until the director has provided notice and the opportunity for hearing in compliance with the CountyCode section 13.15.070.G-K.

B. NOISE

Construction noise shall be minimized to the maximum extent practical and allowable under State and local safety laws. Construction equipment mufflering and hours of operation shall be in compliance with County Code Chapter 8.16. Equipment shall be shut down when not in use. Construction equipment shall normally be staged, loaded, and unloaded on the project site. If project terrain or access road condition require construction equipment to be staged, loaded, or unloaded off the project site (such as on a neighboring road or at the base of a hill), such activities shall only occur between the hours of 8 AM to 5 PM. Exterior winery equipment shall be enclosed or muffled and maintained so as not to create a noise disturbance in accordance with the Code. There shall be no amplified sound system or amplified music utilized outside of approved, enclosed winery buildings.

14. ARCHEOLOGICAL FINDING

In the event that archeological artifacts or human remains are discovered during construction, work shall cease in a 50-foot radius surrounding the area of discovery. The permittee shall contact the Conservation, Development and Planning Department for further guidance, which will likely include the requirement for the permittee to hire a qualified professional to analyze the artifacts encountered and to determine if additional measures are required. If human remains are encountered during the development, all work in the vicinity must be, by law, halted, and the Napa County Coroner informed, so that he can determine if an investigation of

Exhibit B – Conditions of Approval Envy Wines, LLC / Marc Carter Page 8 of 10 the cause of death is required, and if the remains are of Native American origin. If the remains are of Native American origin, the nearest tribal relatives as determined by the State Native American Heritage Commission would be contacted to obtain recommendations for treating or removal of such remains, including grave goods, with appropriate dignity, as required under Public Resources Code Section 5097.98.

15. ADDRESSING

All project site addresses shall be determined by the Conservation, Development and Planning Director, and reviewed and approved by the U.S. Post Office, prior to issuance of any building permit. The Conservation, Development and Planning Director reserves the right to issue or re-issue an appropriate situs address at the time of issuance of any building permit to ensure proper identification and sequencing of numbers. For multi-tenant or multiple structure projects, this includes building permits for later building modifications or tenant improvements.

16. **INDEMNIFICATION**

An indemnification agreement, in the form attached hereto, shall be signed and returned to the County within twenty (20) days of the granting of this approval.

17. AFFORDABLE HOUSING MITIGATION

Prior to County issuance of a building permit, the applicant shall pay the Napa County Affordable Housing Mitigation Fee in accordance with the requirements of County Code Chapter 15.60 or as may be amended by the Board of Supervisors.

18. **PREVIOUS CONDITIONS**

The permittee shall comply with all previous conditions of approval for Use Permits # 01074-UP, # P09-00288-MODMJR and Williamson Act Agricultural Preserve Contract # P09-00436-AGK except as modified by this action. To the extent there is a conflict between previous conditions of approval and these conditions of approval, these conditions shall control and supersede earlier ones.

19. MONITORING COSTS

All staff costs associated with monitoring compliance with these conditions, previous permit conditions and project revisions shall be borne by the permittee and/or property owner. Costs associated with conditions and mitigation measures that require monitoring, including investigation of complaints, other than those costs related to investigation of complaints of noncompliance that are determined to be unfounded, shall be charged. Costs shall be as established by Board Resolution in accordance with the hourly consulting rate established at the time of the monitoring and shall include maintenance of a \$500 deposit for construction compliance monitoring that shall be retained until grant of final occupancy. Violations of conditions of approval or mitigations measures caused by the permittee's contractors, employees, and guests are the responsibility of the permittee.

The Planning Commission may implement an audit program if compliance deficiencies are noted. If evidence of compliance deficiencies is found to exist by the Planning Commission at some time in the future, the Planning Commission may institute the program at the applicant's expense (including requiring a deposit of funds in an amount determined by the Commission) as needed until compliance assurance is achieved. The Planning Commission may also use the data, if it is so warranted, to commence revocation hearings in accordance with section 18.124.120 of the County Code.

20. TEMPORARY AND FINAL OCCUPANCY

All project improvements, including compliance with all applicable codes, conditions and requirements from all departments and agencies with jurisdiction over the project, shall be completed prior to granting of a Certificate of Final Occupancy by the County Building Official, which, upon granting, authorizes all use permit activities to commence. The County Building Official is authorized to grant a Temporary Certificate of Occupancy to allow specified limited use of the project, such as commencement of production activities, prior to completion of all project improvements. In special circumstances, departments and/or agencies with jurisdiction over the project are authorized as part of the Temporary Certificate of Occupancy process to require a security deposit or other financial instrument to guarantee completion of unfinished improvements.

Use Permit Application

The attached Use Permit Application forms must be completed in full and signed by the property owner or their authorized agent. Corporations, partnerships, and the like have special signature requirements as follows:

Corporations (whether for- or non-profit)

The chairman of the board OR the president or vice president AND either the secretary, assistant secretary, chief financial officer, or treasurer. Alternately, the application may be signed by any person who is authorized to do so by a corporate resolution (a copy of the resolution should be provided). <u>General Partnership</u>

Any partner of the general partnership.

Limited Partnership

A general partner of the limited partnership.

Association

The president or general manager of the association.

Application Fee

Total Fees will be based on actual time and materials. A deposit (amount of deposit will be determined at the Pre Application meeting) in the amount of \$_5,000_____, check made payable to County of Napa.

To-Scale Plans

Submit five 24" X 36", one 11" x 17" (or half-scale), and one 8%" x 11" copies of plans indicating the following. All plans must be to an identified architect's or engineer's scale and should legibly and comprehensively include the following details:

- Name, address, and phone number of the owner of record, applicant, engineer, architect, and other project consultants as relevant.
- 2. Assessor's parcel numbers for all depicted parcels, north arrow (whenever possible, north should be at the top of the sheet), and graphic map scale.
- 3. Date of plan preparation (revised plans must be clearly indicated with a new date and marked "revised")

- 4. All property lines of the subject parcel(s) and the dimensions thereof.
- 5. Location and names of all streets and right-of-ways serving the parcel(s).
- 6. Topography and elevation information in sufficient detail to properly assess the relationship of the proposed project and/or use to sea level and the contour of the land. Total project cut, fill, and off-haul should be indicated.
- 7. Location and top-of-bank of all ponds and/or reservoirs on or directly adjacent to the parcel(s).
- 8. Existing and proposed drainage patterns, drainage courses, and any other drainage improvements.
- 9. Limits of the FEMA 100-year floodplain and/or floodway if any portion of the parcel(s) is located within a mapped flood zone.
- 10. Location, dimensions, property-line setbacks, and road setbacks (as applicable) of all existing and proposed improvements, including, without limitation: all existing and proposed structures, caves, waste disposal systems, septic system reserve areas, wells, access roads, parking areas, ADA parking spaces, and outdoor work areas (whether covered or uncovered).
- 11. If the project requests a modification to the County's Road and Street Standards- detailed information on the proposed modification and its environmental context.
- 12. Location and dimensions of the proposed solid waste and recycling storage area.

This letter is in response to your email dated May 31, 2018 which referenced two attachments, the first attachments a memorandum from Chase Beckman at CalFire, dated May 2, 2018 and the second from Daniel Basore with the Napa County Engineering Division dated May 2, 2018. Below, I will summarize our responses.

In response to Mr. Beckman's memorandum. I would like to point out that this request does not include any new construction, simply the allowance to increase the production within the recently constructed production facility which was built in 2014 and conversion of an existing building to allow for tasting. As part of the 2014 construction fire sprinklers were installed and the facility complies with the comments he referenced in Comment #1,7,8,9,12. In response to his request number 2, please see the attached revised road exception request. The conceptual grading plans Mr. Becker reviews are prepared in concept for the Use Permit Modification request. After Use Permit approval, we will be submitting detailed construction and grading plans for construction for review and approval by the required agencies, including CalFire. These detailed plans for the Building and Grading Permits will comply with the current Building Codes and the Napa County Road and Street Standards and will include references were applicable in response to his Comments 3,4, 5, 6, 10 and 11. Because of these reasons, we trust that the Fire's comments are satisfied and these requests can become recommended Conditions of Approval for these requests to be submitted on the plans at the Grading Permit stage.

In response to Mr. Basore's comments, please see the revised request for the very small section

of road to receive an exception to the Local Response Area (LRA) specifications within the Napa County Road and Street Standards. Further, please see the attached revised grading plan which indicates the drainage for the section he referenced.

Please don't hesitate to reach out with any questions. I trust that our application is now complete for processing. Please let me know when you have a hearing date so that I can assure that Mr. Carter is present. Thank you very much for your continued diligence to our request.

Our office represents Mark Carter and Envy Winery ("Winery"), on whose behalf we hereby make the following request for a modification to its existing use permit.

The winery was originally approved in 2002 with Use Permit #010174-UP which allowed for the following:

The construction of a new 3,403 square foot winery producing up to 20,000 gallons of wine per year including retail wine sales, custom crush activities (limited to 25% or 5,000 gallons per year), 25 people per day for by appointment tours and tasting, marketing plan that allow monthly 30-person events and two 100-person annual events, and two full time and two part time employees.

In 2009 the Planning Commission approved a modification to the original use permit, P09-00288-MOD, which allowed the following:

Construction of a new 4,137 square foot barrel storage building with no increase in winery production, marketing program activities or number of employees.

In 2012 the Planning Commission approved modification number P11-01163, which allowed for the following:

> Increase in annual wine production from 20,000 to 50,000 gallons per year, construction of a new additional 3,500 square foot barrel storage building, expansion of the marketing plan to allow food and wine pairings and by the glass or by the bottle consumption as part of daily tours and tastings and one additional marketing event per month of 75 people to allow a total of one 30 person and one 75person event per month and two 100 person events per year; roadway improvements, and expansion of the wastewater treatment facility.

As part of this current request, Envy wines would like to increase the wine production from 50,000 to 100,000 gallons of wine per year. In addition to the production increase we propose to convert the existing laundry room and create a low risk food preparation kitchen to prepare cheese plates on site. The interior modifications to provide for the kitchen will replace the current 89 square foot laundry room, please refer to the attached floor plans for details. The seated tasting area is proposed by expanding the tasting room by 170 square feet. This replaces 265 square feet of production area to accessory area, for an accessory to production ratio of 15 %, see attached breakdown.

There are no requested changes to the winery footprint or facility size and the wastewater will be treated within the current system without a need for expansion. Please review the attached wastewater feasibility report and water availability analysis prepared by Madrone Engineering. This request proposes minor road widening to comply with the road and street standards; because the driveway entrance has an existing easement encumbering the width, we are asking for an exception to the road and street standards within two sections: (1) to allow 18 feet of pavement width instead of the standard width in a short 200- foot location, and (2) to allow a reduced interior radius. Both are to accommodate existing legal constraints as explained in the Road Modification letter.

INDEMNIFICATION AGREEMENT

This indemnification shall include, but not be limited to damages awarded against the County, if any, and cost of suit, attorneys' fees, and other liabilities and expenses incurred in connection with such proceeding that relate to this discretionary approval or an action related to this project taken to comply with CEQA whether incurred by the Applicant, the County, and/or the parties initiating or bringing such proceeding. Applicant further agrees to indemnify the County for all of County's costs, attorneys' fees, and damages, which the County incurs in enforcing this indemnification agreement.

Applicant further agrees, as a condition of project approval, to defend, indemnify and hold harmless the County for all costs incurred in additional investigation of or study of, or for supplementing, redrafting, revising, or amending any document (such as an EIR, negative declaration, specific plan, or general plan amendment) if made necessary by said proceeding and if the Applicant desires to pursue securing approvals which are conditioned on the approval of such documents.

In the event any such proceeding is brought, County shall promptly notify the Applicant of the proceeding, and County shall cooperate fully in the defense. If County fails to promptly notify the Applicant of the proceeding, or if County fails to cooperate fully in the defense, the Applicant shall not thereafter be responsible to defend, indemnify, or hold harmless the County. The County shall retain the right to participate in the defense of the proceeding if it bears its own attorneys' fees and costs, and defends the action in good faith. The Applicant shall not be required to pay or perform any settlement unless the settlement is approved by the Applicant.
