SUBJECT:	Approve the Flash Mixer Replacement Project (CIP 18737) and Concur with CEQA Determination

#### **RECOMMENDATION**

Approve the Flash Mixer Replacement Project (CIP 18737) and concur with staff's CEQA determination that project is Categorically Exempt.

## EXECUTIVE SUMMARY

NapaSan operates two flash mixers in the chlorine contact basin to mix sodium hypochlorite for disinfection. One flash mixer (east channel) was installed in 1998. The second flash mixer (west channel) was installed as part of the recent Phase 1 Recycled Water Expansion Project in 2015. The older mixer in the east channel has failed beyond repair and requires replacement.

The east channel of the chlorine contact basin is required to be able to produce recycled water during treatment of water for river discharge. This happens during dry periods in winter months when a recycled water demand exists from irrigators at the same time as ongoing discharge to the river. Additionally, both mixers (east and west channels) are required to meet peak recycled water demand in the summer. Replacement of the broken flash mixer in the east channel is critical.

Discretionary Justification:	The existing flash mixer for the east channel of the chlorine contact basin has failed, limiting NapaSan's ability to treat wastewater.
