### **RECOMMENDATION**

Receive a presentation on the proposed FY 2017/18 Operating Budget. Consideration for adoption scheduled for June 7, 2017.

### **EXECUTIVE SUMMARY**

Attached is the proposed operating budget for Fiscal Year 2017/18. A preliminary version of this Budget was reviewed by the Finance Committee on April 7, 2017, with the Committee's recommendations included in the proposed operating budget.

The packet includes the following components of the Proposed Operating Budget:

- | Budget summary
- | Position Control Roster
- | Detailed Tables of Revenues and Expenditures
- | Expenditure Budgets by Divisions

The operating budget proposal in total is 0.1% higher in FY 2017/18 than in FY 2016/17. Salary and benefit expenses are proposed to increase 2.1%, the services and supplies budget is proposed to decrease 3.0%, and the debt service budget is set to remain flat.

The 10-Year Capital Improvement Plan and 10-Year Financial Forecast will be presented to and discussed with the Board on May 17, 2017. The combined operating budget and capital improvement plan will be presented to the

Board for consideration and adoption on June 7, 2017.
