SUBJECT: Award Contract for the 2017 Sanitary Sewer Manhole Adjustment Project, Phase VI (CIP 13702)

RECOMMENDATION

Award construction contract for the 2017 Sanitary Sewer Manhole Adjustment Project, Phase VI (CIP 13702) to H&R Plumbing and Drain Cleaning, Inc. for the amount of \$145,500 and; Authorize the General Manager to execute the Agreement with the contractor and issue the notice to proceed, when appropriate.

EXECUTIVE SUMMARY

On June 6, 2017, NapaSan received three bids for the 2017 Sanitary Sewer Manhole Adjustment Project, Phase VI. The engineer's estimate of probable construction cost for the project was \$170,000. H&R Plumbing and Drain Cleaning, Inc. is the lowest qualified bidder in the amount of \$145,500 which is 14% lower than the engineer's estimate.

The second lowest bid was submitted by G.D. Nielson, Inc. in the amount of \$180,625 which is approximately 24% higher than the low bid. The high bid was submitted at \$294,625.

This project will raise to grade approximately 105 sanitary sewer manholes and 21 sanitary sewer flush holes after completion of the City of Napa's annual paving projects.

Notice to Proceed is expected to be issued in early July 2017 and construction is expected to begin in late July 2017. The Contractor has 60 calendar days to substantially complete the project from Notice to Proceed. A summary of the bids received is attached.
