SUBJECT: Adoption of FY 2018/19 Operating and Capital Budgets, and Directing Preparation and Filing of a

Written Report to Collect Sewer Service Charges on the Tax Roll for FY 2018/19

RECOMMENDATION

1) Adopt attached resolution approving the FY 2018/19 Operating and Capital Budget.

2) Adopt attached resolution directing preparation and filing of written report to collect sewer service charges on the tax roll for FY 2018/19.

EXECUTIVE SUMMARY

The proposed FY 2018/19 Operating and Capital Budget, as presented, funds NapaSan's operational requirements and continues funding Capital Improvement Projects in accordance with the Ten-Year Capital Improvement Plan. The draft versions of the proposed Operating Budget and Capital Budget were reviewed by the Finance Committee and the Long Term Planning Committee, respectively. The FY 2018/19 Proposed Operating Budget was presented to the Board on May 2, 2018, and the Proposed Ten-Year Capital Improvement Program and Ten-Year Financial Forecast on May 16, 2018. The attached Budget incorporates direction received by the Board members at these meetings, as well as direction provided through the Strategic Planning process, the Proposition 218 planning process, and facility master plans.

The Budget Document represents and communicates the policy choice set in place by the Board. It identifies the specific goals that each department within NapaSan will achieve this next fiscal year, and it outlines NapaSan's projected financial health for the next ten years.

The budget document, when published, will contain several appendices, including the most recent Strategic Plan and the 2017 Performance Measurement Report. These documents have been excluded from this packet as the Board has already approved these documents. Statistics on NapaSan's operations and the overall community are

also provided as an appendix to provide additional context and history for the reader.

The Letter of Transmittal for the budget, starting on page 5 of the proposed budget, provides a financial overview and specific details about the proposed budget, including areas of strength and weakness in the ten-year financial forecast.

In addition, each fiscal year it is necessary to adopt a resolution directing staff to prepare and file a written report to allow the collection of sewer service charges on the County tax roll. The Public Hearing for FY 2018/19 sewer service charges is scheduled for July 18, 2018.

Staff recommendation is for the Board of Directors to approve the attached resolution for the FY 2018/19 Operating and Capital Budget and the resolution Directing the Preparation and Filing of a Written Report to Collect Sewer Service Charges on the Tax Roll for FY 2018/19.
