## **RECOMMENDATION**

Concur with Staff's CEQA determination that project is Categorically Exempt, and authorize the Purchasing Agent to execute a Work Order with G.D. Nielson Construction Inc. for the amount of \$174,085 for the Sanitary Sewer Manhole Adjustment Project, Phase IV (CIP 13702) and issue the Notice to Proceed, when appropriate.

## EXECUTIVE SUMMARY

The District received no bids on June 7, 2016 for the 2016 Sanitary Sewer Manhole Adjustment Project, Phase IV when the project was bid. Since there were no interested bidders on June 7, requests for quotes (RFQ) were subsequently sent to four contractors. The District received two quotes. The lowest quote was submitted by G.D. Nielson Construction Inc. for \$174,085. The second quote received by Hess Concrete Construction Co., Inc. for \$275,500. The Engineer's Estimate for the project was \$165,000.

This project will raise to grade 125 sanitary sewer manholes and 15 sanitary sewer flush holes after completion of the City of Napa's annual paving projects. Work will be completed within 60 calendar days from notice to proceed.

Unit prices for raising manholes and flush holes in the quote recieved from G.D. Nielson are comparable to previous unit prices paid for similar projects in the last 2 years. Staff recommends that the Board award the work order to G.D. Neilson Construction Inc.
