SUBJECT: Approve PG&E Energy Audit Project - LED Pole/Arm Mounted Fixtures (CIP 17718)

RECOMMENDATION

Approve Project and Concur with Staff's CEQA Determination for the PG&E Energy Audit Project - LED Pole/Arm Mounted Fixtures (CIP 17718).

EXECUTIVE SUMMARY

This project replaces approximately 260 existing exterior high intensity discharge lighting fixtures with LED equivalent lighting at the District's Wastewater Treatment Plant and Water Recycling Facility, resulting in annual energy savings and receipt of an energy incentive offered by PG&E.

FISCAL IMPACT

Is it currently budgeted? Yes

Where is it budgeted? There is \$78,100 budgeted for this project in the FY 16/17 Capital

Improvement Plan.

Is it Mandatory or Discretionary? Discretionary

Discretionary Justification: The project will result in an estimated annual energy savings of \$10,411. The

2012 PG&E energy audit identified a 5.5 year payback for implementation of

this energy efficiency measure.

Is the general fund affected? No

Future fiscal impact: The 2012 PG&E energy audit report estimated annual electricity savings of

\$10,411 for implementing this energy efficiency measure.

Consequences if not approved: If not approved, the District will not replace existing exterior high intensity

discharge lights with equivalent LED fixtures. Annual energy savings

associated with this replacement will not occur and the District will not receive

the \$13,700 incentive proposed by PG&E.

Additional Information: PG&E has identified a \$13,700 incentive payment to the District for

implementing this project.

ENVIRONMENTAL IMPACT

Staff performed a preliminary CEQA review of this project and determined the project is Categorically Exempt. The project consists of replacing existing lighting fixtures involving negligible or no expansion of capacity, which corresponds to Categorical Exemption 15302(c) of the California Environmental Quality Act (CEQA) guidelines. If the Board concurs with this determination, staff will file the attached Notice of Exemption.

BACKGROUND AND DISCUSSION

In 2012 PG&E sponsored an Energy Audit Report for the District. The report identified and prioritized potential energy and demand savings opportunities (energy conservation, energy efficiency, time-of-use management, self-generation). The report also estimated costs to implement energy savings projects, resulting annual energy savings, and potential incentives from PG&E for implementing the projects. This project is one of the high priority energy efficiency projects listed in the report.
