SUBJECT: Concur with CEQA Determination, Set Bond Amount, and Authorize Execution of Agreements for

Black Walnut Circle Subdivision

RECOMMENDATION

Concur with CEQA determination in City of Napa Resolution R2015-58, prepared and adopted by the City of Napa, lead agency under CEQA for the development project; set bond amount at \$111,500; and authorize Chair to execute the Improvement Agreement, Private Sanitary Sewer Main Agreement, and Indemnification Agreement for the Black Walnut Circle Subdivision.

EXECUTIVE SUMMARY

This development, by Black Walnut 7, LLC, is for an 7-lot subdivision located on 2012 Imola Avenue (APN 046-311-013) in Napa. In order to provide sanitary sewer service to this project, the developer will install 183 lineal feet of 6-inch diameter public sewer main in Wine Country Court. The District requires the developer to enter into an Improvement Agreement for the installation of public sewer facilities.

Additionally, the owner will install approximately 132 lineal feet of a private 6-inch sanitary sewer main to serve four parcels. Each parcel will have a separate 4-inch lateral connected to the 6-inch private main. The Private Sanitary Sewer Main Agreement outlines the owner's responsibilities and will be recorded upon execution by all the parties.

The development plans to install porous asphalt pavement in the project entrance over a portion of t new public main. The Indemnification Agreement outlines the owner's responsibilities for removal and replacement of the porous pavement, if required by the District for access to maintain or repair the sewer main. The Indemnification Agreement will be recorded upon execution by all the parties.

Improvement plans for the required sanitary sewer facilities have been prepared in conformance with District's standards. A copy of the plans are available for review at the District office.
