SUBJECT: Award Task Order for Sewer Service Charge Rate Methodology and Capacity Charge Study

RECOMMENDATION

Authorize the Purchasing Agent to execute Task Order No. 23 with Carollo Engineering, Inc. to provide consulting service regarding residential sewer service charge methodology design and the calculation of capacity charges, in the amount of \$102,486.

EXECUTIVE SUMMARY

This project includes the development and analysis of several options for rate setting residential sewer service charges. The study does not evaluate the amount of money necessary to be collected from rates, but instead will evaluate different rate structures to find the most fair and equitable methodology for structuring the rates. The study will look at the potential of a volumetric rate, evaluate the current percentage factors used for setting residential rates, and explore different billing options. This project also includes an update to the capacity charge and will explore different methods for charging that fee on residential development.

Carollo Engineers was selected based on upon their prior experience working with NapaSan on the analysis of city water use data and its relationship to sewer usage for specific properties, and on prior experience with NapaSan in developing a new capacity charge methodology for commercial customers. Under this Task Order, Carollo will conduct analysis on various methodology options for residential sewer service charges and calculate the rate impacts for each option. Carollo will also update NapaSan's capacity charge fee and will evaluate different methodologies for imposing that fee on residential development. It is expected that the initial findings and options will be presented to the Board in early 2018, with outreach and a final recommendation completed by the end of May 2018.

This project was identified in the Strategic Plan under Goal 2: Financial Stability, Objective 2A, "Conduct study of sewer service charge and capacity charge methodologies for residential customers and development, and make

recommendations for Board consideration."
