### **RECOMMENDATION**

Authorize the Purchasing Agent to execute a task order with Consolidated CM to provide Construction Management, Testing, and Inspection Services for the Recycled Water Reservoir Improvements Project (CIP 16716) in the amount of \$161,394.

#### EXECUTIVE SUMMARY

Consolidated CM will provide third party construction management, testing, and inspection services during construction of the Recycled Water Reservoir Improvements Project. Consolidated CM's scope of work includes providing full time staffing to monitor the contractor's work for compliance with the contract documents, quality assurance, and safety. The consultant's work also includes coordinating work, conducting project meetings, maintaining project record drawings, preparing daily inspection reports, reviewing monthly progress payments, and assistance with funding requirement compliance.

#### BACKGROUND AND DISCUSSION

NapaSan staff managed a competitive consultant selection and procurement process for construction management and inspection that included outreach to small and disadvantaged business entities as required by project funding sources. Requests for proposal were sent to nineteen (19) firms and two (2) firms were responsive. Based on staff review of the proposals, staff selected Consolidated CM's team as the most qualified team to perform the required services. Third-party construction management offers independent review of project issues and evaluation of solutions that best benefit the project.
