The scope includes rehabilitation of chemical storage building and plant paving. The engineer's estimate for the project totals \$1,428,000. AUTHORIZE THE PURCHASING AGENT TO EXECUTE TASK ORDER 30 WITH HDR ENGINEERING, INC. TO PROVIDE ENGINEERING DESIGN SERVICES FOR THE PRIMARY CLARIFIER AND DAF CLARIFIER REHABILITATION PROJECT (CIP 16712) IN THE AMOUNT OF \$173,351.

Karl Ono, Associate Engineer, gave a presentation on the Primary Clarifier and DAF Clarifier Rehabilitation Project. He reported on the background and condition assessment findings on the primary clarifiers, DAF clarifier and the chlorine contact basins. The priority on the rehab project begins with the primary clarifiers, then the DAF clarifier with the chlorine contact basins to follow. Ono reviewed the general project scope and anticipated schedule. The design of the project will take place between February to July 2019. The project will go out to bid in August 2019 and construction will begin in summer, 2020.
