Simon Kobayashi, Associate Engineer, gave a presentation on the MST Recycled Water Truck Fill Station Project. He reviewed the location, design and construction of the pump station. Kobayashi discussed the project benefits and funding. He reported the project was coordinated with Napa Valley Unified School District (NVUSD) and Napa County. NapaSan entered into an Easement Agreement for the pump station from NVUSD. The engineer's estimate for the project was \$431,875 and the final contract amount is \$384,158.80. Total costs including design, permitting, project management, and NapaSan staff time is approximately \$571,000. The County of Napa will reimburse NapaSan for all of the project costs.
