Mark Koekemoer, Regulatory Compliance Manager, updated the Board on the changes referenced in the proposed ordinance. He reported that staff conducted a Local Limits Assessment per our new NPDES Permit. The report was sent to the San Francisco Bay Regional Water Quality Control Board (RWQCB), who had 60 days to review and provide comments. The District did not receive any comments from the RWQCB, which clears the path for NapaSan to adopt the newly proposed local limits in our ordinance. The changes in the proposed ordinance are based on the Local Limits Assessment. The Ordinance also clarifies code language regarding signature requirements for industrial users, and adds a definition for polyaromatic hydrocarbons, as recommended in NapaSan's most recent Pretreatment Compliance Audit.

Matt Lemmon, Associate Engineer, gave an overview to the Board on the 2017 Collection System Rehabilitation Project. The project will consist of rehab/replacement of approximately 30,000 LF (5.7 miles) of sewer mains and 603 sewer laterals. The project will also replace or rehabilitate 30 manholes or flush holes. The project is being coordinated with the City of Napa's street paving. The project will cover several locations in the City as located on the map. The engineer's estimate for the project is \$5,200,000.

Lemmon reported that the notice inviting bids would go out January 13, 2017 with a bid opening date of February 14, 2017. Award of construction will be March 1, 2017 with an estimate substantial completion date in October 2017.

He reported that NapaSan crews have been out in force monitoring our sewer lines and bypassing and moving water from overloaded sewer lines to other areas in the system. He reported there were overflows of diluted water due to system overload. NapaSan rented an additional Vactor vacuum truck to assist the crews, and the water truck was used as a vacuum truck, to help reduce overflows. Healy reported that crews have been doing a great job monitoring the system during the storms. Director Gravett commented that we should get the story out on how the crews worked hard during the storm events. Chair Techel recommended staff have discussions with the City and County staff to debrief on the storm and changes due to the flood control and bypass improvements.
