Robin D. Gamble, Junior Engineer, delivered a presentation to the Board on the LCWD Recycled Water Pipeline Project, which also included a recommendation to adopt a Resolution accepting completion of the project. Ms. Gamble discussed the project goals of reducing groundwater and surface water extraction for agriculture in the LCWD area, also mentioning construction features, project milestones and results. Ms. Gamble also gave an overview of project costs and funding sources, making note that ratepayers were not responsible for any of the costs.

Director Graves proposed finding a permanent location for the project signage commemorating project funding and agencies involved.

- b. **Receive presentation from Staff on the District's new NPDES permit adopted July 13, 2016 by the Regional Water Quality Control Board.**

James Keller Jr., Plant Manager, along with consultant Monica Oakley and Mark Koekemoer, Lab Supervisor, presented the District's new NPDES permit, a federal and state permit required by any entity that wants to discharge into the waters of the US, issued by the Regional Water Quality Control Board on July 13, 2016 under a five-year term effective September 1, 2016. Mr. Keller pointed out the areas of the District that the permit regulates, and explained the permitting process and the permit's impact on the District. Ms. Oakley, who helped with permit negotiations, explained the hearing process, went over notable permit revisions and negotiation successes, and noted specific operational benefits the District will have as a result. She stated that the Regional Water Board members commended the District on its perfect compliance during the previous permit term, and she added that the District has been in perfect compliance with the effluent limits since 2002. The Regional Water Board members also commended the District on its extensive recycled water program. Mr. Koekemoer spoke on the more technical aspects of the permit, elaborating on studies conducted and data

analysis, and highlighted the potential cost savings to the District using it as evidence that the District is effectively managing the system well.

Stephanie Turnipseed, Pollution Prevention and Outreach Coordinator, presented the final draft of the communications plan to the Board, highlighting the two core goals; increasing public awareness and to inform and educate District customers. Turnipseed discussed elements of the plan such as the District's core messages, reliability, environmental stewardship, resources conservation, financial stewardship, and communal ownership & responsibility. Turnipseed also included a breakdown of estimated hours involved, workload changes, and a proposed timeline for implementation.

Early results show a decrease in chlorides coming through the Riverpark pump station. District staff will continue to examine the area for leaks.

The Board commended District staff on their ability to detect, identify and repair the leak.
