## 9. ZAPOLSKI & RUDD, LLC / ZAPOLSKI-RUDD WINERY – USE PERMIT REQUEST #P06-01131-UP

**CEQA STATUS:** Mitigated Negative Declaration Prepared. According to the proposed Mitigated Negative Declaration, the proposed project would have, if mitigation measures are not included, potentially significant environmental impacts in the following areas: population/housing and transportation/traffic.

**REQUEST:** Approval of a Use Permit to establish a new 120,000 gallon per year wine production facility to include: (1) construction of a 34,510 square foot building for all

operations; (2) parking for 28 vehicles; (3) three full-time employees and six part-time employees for crush and bottling; (4) two new driveways on Devlin Road and Sheehy Court; (5) on-site pre-treatment of process waste with underground tanks for effluent storage, recirculation, settling tanks, and associated equipment; (6) landscaping; (7) free-standing and building mounted signs; (8) hours of operation from 7:00 a.m. to 5:00 p.m. seven days a week; and, (9) connection to municipal water and sewer services provided by the City of American Canyon and the Napa Sanitation District, respectively. The project site is located on a 2.56 acre parcel on the northwest corner of Devlin Road and Sheehy Court within the IP:AC (Industrial Park:Airport Compatibility) zoning district. (Assessor's Parcel #: 057-250-028) Napa.

Commission voted to adopt the Mitigated Negative Declaration and approve the Use Permit #P06-01131-UP with Conditions of Approval.

**CEQA STATUS:** Categorically Exempt pursuant to Section 15301 of the California Environmental Quality Act (Class 1 - Existing Facilities).

**REQUEST:** The Commission recommend that the Board of Supervisors approve a use permit recognizing the unauthorized expansion of a pre-existing flea market use as a legal "transitional use". This project site is located on eight parcels totaling 20.21 acre parcel on the east side of Napa Vallejo Highway (State Highway 29) between Café Court, South Kelly Road and Case Court within the IP:AC (Industrial Park:Airport Compatability) and GI:AC (General Industrial:Airport Compatability) split combination zoning districts.
