February 1, 2006

1. Call to Order.

THE CONSERVATION, DEVELOPMENT AND PLANNING COMMISSION OF THE COUNTY OF NAPA MET IN REGULAR SESSION, WEDNESDAY, FEBRUARY 1, 2006 AT 9:00 A.M. THE MEETING WAS CALLED TO ORDER BY CHAIR FIDDAMAN AT 9:01 A.M.

 DIRECTOR OF CONSERVATION, DEVELOPMENT AND PLANNING HILLARY
 GITELMAN REPORTED THAT THE BOARD OF SUPERVISORS HAD RECENTLY
 APPROVED THE CHANGES TO THE TEMPORARY EVENTS ORDINANCE AND THE
 MONTALCINO PROJECT.

DIRECTOR GITELMAN ALSO REPORTED THAT THE GENERAL PLAN STEERING COMMITTEE HAD BEEN DISCUSSING LAND USE ISSUES. SEVERAL PUBLIC WORKSHOPS TO FURTHER DISCUSS THE ISSUE WERE ALSO BEING PLANNED FOR LATE FEBRUARY/EARLY MARCH.

10. PRESCOTT & KRISTINE ASHE / ASHE VINEYARD, LLC. / ASHE VINEYARDS & WINERY – USE PERMIT REQUEST #P05-0373-UP

Request: Approval of a Use Permit to establish a 2,500 gallon per year winery to include the following: (1) conversion of the 1,529 square foot lower level of an existing $\pm 5,200$ square foot single family residence to be used for fermentation, barrel storage, case goods storage, and laboratory for a winery totaling 1,529 square feet; (2) one parking space and one loading space; (3) one part-time employee; (4) installation of a waste disposal system and a "Hold and Haul" tank; (5) improvements to the project access road (widening and paving); and, (6) installation of a

The project is located on a 35.33 acre parcel on the east side of St. Helena Highway (State Highway 29), approximately ½ mile southeast of its intersection with Oakville Cross Road, within an AP (Agricultural Preserve) zoning district. (Assessor's Parcel #: 031-080-018) 7688 St. Helena Highway, Napa (in the Oakville vicinity). CEQA Status: Mitigated Negative Declaration Prepared. 12. CONSIDERATION OF REVOCATION OF USE PERMIT #P04-0551-UP ISSUED ON JULY 20, 2005 TO JAYSON WOODBRIDGE AND ONE TRUE VINE, LLC

(1:30 p.m.) Project approved was for the establishment of a 19,000 gallon per year winery to include: 1) use of 10,985 square feet of caves for winery production activities, crushing, fermentation, barrel aging and storage, bottling, case good storage, administration offices and laboratory for a winery totaling 10,985 square feet; 2) two full-time employees; 3) two parking spaces; 4) installation of a waste disposal system including a hold and haul program with vineyard application for processed wastewater; and, 5) improvements to the project access road, widening and paving located on a 40-acre parcel on the west side of Crystal Springs Road approximately one mile southeast of its intersection with Silverado Trail within an AW (Agricultural Watershed) zoning district, Napa County Assessor's Parcel Number 021-072-044, 565 Crystal Springs Road, St. Helena. Revocation of Use Permit No. P04-0551-UP is requested on the grounds that a person making use of the use permit is violating or has violated conditions thereof; the use for which the use permit was granted is being, or has been, exercised contrary to the terms or conditions of such approval; and the use for which the approval was granted is being exercised as to be detrimental to the public health, safety or general welfare. The purpose of the revocation hearing before the Napa County Conservation, Development and Planning Commission is to give staff, the permittee and members of the public an opportunity to present evidence as to whether or not the Commission should revoke the use permit or take other action it deems appropriate.
