Chair Hall and members of the Agricultural Protection Advisory Committee,

Yesterday, I stated that the next meeting would deal with variances, in order to stay on the schedule adopted by the Committee at their first meeting. That was incorrect.

The subject of variances is not scheduled until June 22. The next meeting on June 8 was scheduled to discuss the estate grape requirement, which was considered yesterday by the Committee (see adopted schedule below). I failed to take into account the additional meeting on May 26 that was later added to the Committee's schedule.

As a result, the Committee now has a free meeting. Unless there are any objections, the agenda for the June 8 meeting will be to provide a forum for exploring (and possibly taking action on) the range and intensity of non-agricultural uses allowed within agricultural zones. It seems to me that the topic was one that was of interest to the majority of committee members and that expanded discussion would be of general benefit.
