Poison centers across the country receive over ten thousand poison exposure calls a day. Even though children younger than 6 account for half of all the poison exposure calls, adults account

for 92 percent of all poison-related deaths. You can contact the poison centers by dialing their toll-free number (800-222-1222) from anywhere in the nation and be connected with poison control professionals to assist you.
