#### 4. SAFETY MOMENT - National Poison Prevention Month

March 19-25 is National Poison Prevention Week. Established by Congress in 1961, National Poison Prevention Week's goal is to heighten awareness of the more than 2 million poisonings reported across the country each year, and to educate the public on how to prevent most accidental poisonings from ever happening. If you do encounter the need to report a possible poisoning, you can call 1-800-222-1222 anywhere in the U.S. and be connected to the nearest Poison Control Center. For Napa County the Poison Control Center is located in San Francisco at the Department of Clinical Pharmacy, UCSF. Please take some time during Poison Prevention week to focus on the prevention of accidental poisonings.
