#### 4. SAFETY MOMENT - Focus on Driving

U.S. fatalities from traffic accidents rose 7.2% last year to 35,092—the largest increase in 50 years—and distracted driving played a role in 10% of those deaths, according National Highway Traffic Safety Administration figures released last month. NHTSA found that fatalities from "distraction-affected" crashes increased 8.8% to 3,477 from 3,197 for the same period. Behind the wheel, nothing is more important than focus. Stay aware of road and weather conditions, traffic, pedestrians, your speed, and your need to be in complete control of your vehicle. Do not take a call, text, or let your eyes or mind wander to other people in your car, or do anything other than focus on your driving. If any of the above things must be done, pull safely off the road and out of the traffic flow to do them. Every day people are killed and injured simply because a driver is distracted. Don't be one of them.
