#### 4. SAFETY MOMENT - CPR/AED Awareness

Congress unanimously passed a resolution to set aside June 1-7 each year as National CPR and AED Awareness Week to spotlight how lives can be saved if more Americans know CPR and how to use an AED. The American Red Cross encourages people to get trained in CPR along with how to use an automated external defibrillator (AED). Statistics show that the majority of cardiac arrests happen in the home or workplace, so it is likely you could be helping someone you know. The Red Cross First Aid, CPR and AED program is designed to help lay responders such as parents, teachers, daycare providers and employees recognize and respond to cardiac, breathing and first aid emergencies. Participants learn how to give immediate care to a suddenly injured or ill person until more advanced medical personnel arrive and take over.
