4. SAFETY MOMENT - What's New in High Blood Pressure

Recent guidelines released by the American Heart Association and the American College of Cardiology lower the threshold for high blood pressure, also known as hypertension. Millions of Americans may require lifestyle changes or medication treatment earlier than previously thought.

Tips to prevent and manage high blood pressure:

- 1) Know your numbers. If your blood pressure is 130/80 or higher, talk with your doctor about whether you need lifestyle changes or require treatment.
- 2) Lifestyle changes can be as important as medications. You may be able to reduce the risk of high blood pressure if you:
- a. Eat a healthy diet/maintain a healthy weight
- b. Don't smoke
- d. Stay or get physically active.
- 3) If you use medications to lower your blood pressure, take them as your doctor directs. Work with your doctor to monitor your blood pressure and how well the medications work for you.
