#### 4. SAFETY MOMENT - Slips, Trips and Falls

Slips, trips, and falls are a major cause of preventable injuries and deaths in the workplace. You might be a well-coordinated person, strong and in control of your body, but you could still fall down. Review these tips and hazards to refresh your memory on fall prevention.

Your Work Area - In a plant, warehouse or office, the most common causes of falls are tripping and slipping.

-Dry the floor after spilling any liquid. Don't just wipe it up; wipe it dry.

-Watch where you are going.

-Don't carry anything that blocks your vision of the walkway. Get help.

-Don't string a temporary cord across an aisle or walkway. If you have to do it, mark it clearly so others don't trip over it.

Outside Your Work Area - Be aware of single steps and uneven surfaces.

-Don't run or rush through halls or aisles.

-Take steps one at a time and use the handrail.
