Project Goals

- Reduce groundwater overdraft in MST
- Recycled Water Beneficial Reuse




Project Elements

- 5 miles of new recycled water pipeline
- New 1400 GPM booster pump station
- Recycled water services for 52 properties
 - 36 properties at start of construction
 - 16 properties added during construction



Construction Costs

- \$11.1M Total Construction Cost
 - Pipeline: \$8.6M
 - Pump Station: \$2.5M
- Total Change Orders: \$1.02M
 - Pipeline: \$944k (12.3%)
 - Pump Station: \$80k (3.3%)
- Notable Change Orders (Pipeline)
 - Rock Excavation (\$546k)
 - Added Customer Services (\$160k)
 - Coombsville Road Site Conditions (\$123k)



Project Costs & Grant Summary

- \$13M Total Project Cost
 - Design, Construction, Construction
 Management, Environmental, NSD Staff
- \$3.25M WaterSMART Grant (Federal)
 - 25% of total project cost reimbursed to NSD
- \$2M Prop 84 Grant (State)
- \$3M Prop 1 Grant (State)
- 1% interest SRF Loan (State)
- All NSD costs reimbursed by County/CFD
- COST TO NSD RATE PAYERS: \$0



Results

- Projects complete on schedule for Spring 2016 Recycled Water Delivery to MST
- Reduced overdraft of MST groundwater
- \$8.25M Grant Money Obtained
 - WaterSMART, Prop 1, Prop 84
- Napa County/NSD anticipate a <u>significant</u> reduction to participating properties' CFD tax assessments
- COST TO NSD RATE PAYERS: \$0



Moving Forward

- Extension of MST System currently in planning between Napa County and NSD Staff
 - Recycled water allocation still available to MST
 - Up to 4 miles of additional recycled water pipeline
 - County Planning Formation of a new CFD
 - Tulocay Cemetery, Silverado Middle School, Vineyards, others
 - \$1M available to NSD (25% of project cost) through WaterSMART
 - Extension eligible for additional Prop 1 funding
