AWARD CONSTRUCTION CONTRACT FOR THE SIPHON VAULT HATCH REPLACEMENT PROJECT (CIP 16718) TO PLEASANTON ENGINEERING CONTRACTORS, INC. FOR THE BID AMOUNT OF \$45,000 AND AUTHORIZE THE GENERAL MANAGER TO EXECUTE THE AGREEMENT WITH THE CONTRACTOR AND ISSUE THE NOTICE TO PROCEED, WHEN APPROPRIATE.

Matt Lemon, Associate Engineer, gave a presentation to the Board on the bid results and timeline of the construction project. He gave an over of the project which includes replacing three aluminum hatches with sealed composite hatches, installing a jumper pipe to vent air from one side of the vault to the other, and installing an odor-removal device. Lemon indicated the benefits of vault hatch replacement are to eliminate odor complaints received from neighboring residences, provide better access for routine cleaning, and prevent buildup of corrosive gases. The District received five bids on the project with Pleasanton Engineering Contractors, Inc. being the lowest bidder. The engineers estimate on the project was \$80,000. District staff will perform construction management and inspection services for the project. Construction will begin in April with anticipated completion in June of 2016.

## 9. **GENERAL MANAGER REPORT:**

- a. General Manager Healy reported that two outreach meetings have been scheduled to discuss the proposed rate increase. On February 22<sup>nd</sup> at 6:30 p.m. a meeting will be held at the Boys & Girls Club, and on Tuesday, February 23<sup>rd</sup> at 6:30 p.m. a meeting will be held at the Napa Valley College, Community Room in Building #1700. He reported that stations will be set up in the meeting rooms for the public to ask questions and receive information on the reason for the increase, proposed capital projects, accomplishments from the last 10 years, and the Prop. 218 process.
- b. Healy reported that he will be making a presentation to the Napa Kiwanis Club at 12:00 noon on Thursday, February 25<sup>th</sup> regarding the proposed rate increase.
- c. Healy reported that on Thursday, February 11<sup>th</sup> he accompanied Director Graves to a presentation Graves gave to the Napa Chamber of Commerce regarding the upcoming proposed rate increase.
