Credit Card Fees

What are the fees charged by credit card processor?

Credit Card Fee	NapaSan Pays Fee	Customer Pays Fee
Percent of Sale	1.42%	2.34%
Per Transaction	\$0.12	\$0
eCheck / ACH	NapaSan Pays Fee	Customer Pays Fee
Per Transaction	\$0.95	\$1.50

Note: Several credit card processing companies were contacted. Three were interested in our business. Above represents the best fee options for NapaSan and customer.

What are the estimated annual fees for accepting credit cards?

Invoice Type	NapaSan Pays	Customer Pays
Recycled Water	\$2,331	\$3,786
Monthly SSC	\$1,534	\$2,521
Annual SSC	\$2,501	\$4,122
Waste Haulers	\$436	\$713
Permits & Inspections	\$1,164	\$1,878
RW Signs	\$11	\$15
Total	\$7,977	\$13,036

Legal Issues

- Can NapaSan pass on the fees to customers?
 - Yes. Governments are exempted from the law that doesn't allow this for retailers
- Other Requirements
 - To pass on the transaction fees to customers, the policy must be approved by the Governing Body



Policy Recommendation

- 1. NapaSan should start accepting credit cards and eChecks/ACH for certain payments.
- 2. Transaction and processing fees should be passed on to the customer.
