Background

- Initial MST Project completed in 2016
 - 5 miles of distribution pipeline
 - Booster Pump Station
 - 52 participating properties
- Expandable System
 - Additional RW available to MST following the project
 - Napa County and NapaSan continued outreach to interested parties




Project Elements

- 1.4 miles of new 18" and 8" recycled water mains – Fusible PVC Pipe
- (3) "Anchor" properties
 - NVUSD's Silverado Middle School
 - Tulocay Cemetery
 - 12 acre vineyard property
- (1) bore and jack creek crossing

Project Challenges

- September 2017 completion required for WaterSMART grant
- SRF loan application on critical path
- Silverado Middle School & Mount George Elementary School
 - Project constraints require work during summer breaks
- Rock Excavation
- Bore and Jack creek crossing
- Public Impacts Traffic & Residents
 - To be mitigated with outreach

Project Funding

- \$3.3M Total Project Cost
 - \$2.3M Construction
 - \$1M Soft Costs (design, environmental, CM, NapaSan staff time)
- \$825,000 WaterSMART Grant (Federal)
 - 25% of total project cost
 - NBWRA
- All NapaSan costs reimbursed by Napa County
 - Low interest SRF Loan (State)
- COST TO NSD RATE PAYERS: \$0

 - Notice to Proceed
- Construction Period: May September 2017
