
Exhibit A
Sewer Easement Quit Claim

A portion of the Fifteen-Foot Sanitary Sewer and Public Utility Easement granted from The Roman Catholic Bishop of Santa Rosa to Napa Sanitation District recorded July 12, 1967 in Book 769 page 108 of Official Records of Napa County described as follows:

Commencing at a point on the northwesterly line of that certain 30-acre tract of land described in deed from George Bruno et us to Richard K. Whitmore and recorded in Book 347 Official Records, County of Napa, at Page 140, said point being distant thereon North $56^{\circ}11'22''$ East 60.02 feet from the northwesterly corner of the above mentioned 30-acre tract; thence along said northwesterly line North $56^{\circ}11'22''$ East to the point that bears South $56^{\circ}11'22''$ West 435.93 feet from the southwest line of Solano Avenue also being the **Point of Beginning**; thence North $56^{\circ}11'22''$ East 435.93 feet to the southwest line of Solano; thence along the south line of Solano Avenue North $35^{\circ}16'38''$ West to the line 15 feet distant and parallel with above mentioned northwesterly line; thence South $56^{\circ}11'22''$ West 437.92 feet; thence 15.09 feet to the Point of Beginning.
