The revised application requesting approval to establish a 30,000 gallon per year winery including the construction of a new building, crush pad, and dwelling and up to 15 visitors per day and 2 full time and 2 part time employees among other items detailed in application materials received January 24 and May 31 has been reviewed. This Division has no objection to approval of the application with the following conditions of approval:

- Proposed food service will be catered; therefore, all food must be prepared and served by a Napa County permitted caterer. If the caterer selected does not possess a valid Napa County Permit to operate, the applicant shall refer the business to this Division for assistance in obtaining the required permit prior to providing any food service.
- 2. Pursuant to Chapter 6.95 of the California Health and Safety Code, businesses that store hazardous materials above threshold planning quantities (55 gallons liquid, 200 cubic feet compressed gas, or 500 pounds of solids) shall obtain a permit and file an approved Hazardous Materials Business Plan with this Division within 30 days of said activities. If the business does not store hazardous materials above threshold planning quantities, the applicant shall submit the Business Activities Page indicating such.
- 3. The applicant shall file a Notice of Intent (NOI) and complete a Storm Water Pollution Prevention Plan with the State of California Water Resources Control Board's (SWRCB) Industrial Permitting program, if applicable, within 30 days of receiving a temporary or final certificate of occupancy. Additionally, the applicant shall file for a storm water permit from this Division, if applicable, within 30 days of receiving a temporary or final certificate of occupancy. Certain facilities

may be exempt from storm water permitting. A verification inspection will be conducted to determine if exemption applies.'

- 4. A permit to construct the proposed subsurface drip system must be secured from this Division prior to approval of a building clearance (or issuance of a building permit) for any structure that generates wastewater to be disposed of by this system.
- 5. Plans for the proposed alternative sewage treatment system shall be designed by a licensed Civil Engineer or Registered Environmental Health Specialist and be accompanied by complete design criteria based upon local conditions. No building clearance (or issuance of a building permit) for any structure that generates wastewater to be disposed of by this system will be approved until such plans are approved by this Division.
- 6. No rain water may be allowed to enter the proposed waste water treatment system. The waste water treatment system is designed to treat waste water only and is not sized to accommodate rainfall/storm water runoff.
- 7. An annual alternative sewage treatment system monitoring permit must be obtained for the alternative sewage treatment system /private sewage disposal system prior to issuance of a final on the project. The septic system monitoring, as required by this permit, must be fully complied with.
- 8. The use of the absorption field/drain field area shall be restricted to activities which will not contribute to compaction of the soil with consequent reduction in soil aeration. Activities which must be avoided in the area of the septic system include equipment storage, traffic, parking, pavement, livestock, etc.
- 9. The applicant shall provide portable toilet facilities for guest use during events of 100 persons as indicated in the septic feasibility report/use permit application. The portable toilet facilities must be pumped by a Napa County permitted pumping company.
- 10. All solid waste shall be stored and disposed of in a manner to prevent nuisances or health threats from insects, vectors and odors.
- 11. During the construction, demolition, or renovation period of the project the applicant must use the franchised garbage hauler for the service area in which they are located for all wastes generated during project development, unless applicant transports their own waste. If the applicant transports their own waste, they must use the appropriate landfill or solid waste transfer station for the service area in which the project is located.
- 12. Adequate area must be provided for collection of recyclables. The applicant must work with the franchised garbage hauler for the service area in which they are located, in order to determine the area and the access needed for the collection site.

- 13. All diatomaceous earth/bentonite must be disposed of in an approved manner. If the proposed septic system is an alternative sewage treatment system the plan submitted for review and approval must address bentonite disposal.
- 14. Because the proposed number of visitors, employees and residents only exceeds 25 for less than 60 days of the year the proposed water system to serve this project is not required to be regulated as a small public water system by this Division under California Code of Regulations, Title 22, or Napa County Code. Therefore, we have no comment as to its adequacy at this time. The applicant will be required to provide minimal information on the water system prior to approval of a building permit, and may wish to retain the services of a consultant in this matter.

The Napa County Fire Marshal's Office has reviewed the Use Permit Modification application for the existing winery expansion. I am requesting that the comments below be incorporated into the project conditions should the Planning Commission approve this project.

- 1. All construction and use of the facility shall comply with all applicable standards, codes, regulations, and standards at the time of building permit issuance.
- 2. All fire department access roads shall comply with Napa County Public Works Road and Street Standards.
- 3. The numerical address of the facility shall be posted on the street side of the buildings visible from both directions and shall be a minimum of 4-inches in height on a contrasting background. Numbers shall be reflective and/or illuminated.
- 4. All buildings over 3,600 square feet shall be equipped with an automatic fire sprinkler system conforming to NFPA 13 2010 edition with water flow monitoring to a Central Receiving Station.
- 5. The required fire flow for this project is 200 GPM for a 60 minute duration with 20 psi residual pressure. A UL listed fire pump conforming to NFPA 20, 2010 edition may be required to meet or exceed the required fire flow for the project.

- 6. Provide a minimum of 6,000 gallons of water dedicated for fire protection. Water storage for fire sprinkler systems shall be in addition to the water storage requirement for your fire flows and domestic use.
- 7. Provide fire department access roads to within 150 feet of any exterior portion of the buildings. Fire department access roads shall be a minimum of 20 feet in width with a 14 foot clear vertical clearance.
- 8. All driveways and roads shall comply with the Napa County Public Works Road and Street Standards.
- 9. Blue dot reflectors shall be installed 12-inches off centerline in front of all fire hydrants.
- 10. All fire hydrants shall be painted chrome/safety yellow.
- 11. Approved steamer fire hydrants shall be installed a maximum distance of 250 feet from any point on approved fire apparatus access roads. Private fire service mains shall be installed, tested and maintained per NFPA 24 2010 edition.
- 12. Currently serviced and tagged 2A 10BC fire extinguishers shall be mounted 3.5 to 5 feet from the top of all extinguishers to the finished floor and be reachable within 75 feet of travel distance from any portion of all buildings.
- 13. All exit doors shall open without the use of a key or any special knowledge or effort.
- 14. Install illuminated exit signs throughout the buildings per the California Building Code 2010 edition.
- 15. Install emergency back-up lighting throughout the buildings per the California Building Code 2010 edition.
- 16. Install laminated 11" x 17" site plans and building drawings in NCFD specified KNOX CABINET. Two Master keys to all exterior doors shall be provided in the KNOX CABINET. A PDF file shall be sent to the Napa County fire Marshal's Office.
- 17. Beneficial occupancy will not be granted until all fire department issues have been, tested and finaled.
- 18. Provide 100 feet of defensible space around all structures.
- 19. Provide 10 feet of defensible space fire hazard reduction on both sides of all roadways of the facility.
- 20. Fire apparatus access roads shall be designed and maintained to support the imposed loads of fire apparatus in all weather conditions.
- 21. Designated fire lanes shall be painted red with white 4 inch high white letters to read "NO PARKING FIRE LANE-CVC22500.1" stenciled on the tops of the curbs every 30 feet.

- 22. Barricades shall be provided to protect any natural gas meter, fire hydrants, or other fire department control devices, which may be subject to vehicular damage.
- 23. Technical assistance in the form of a Fire Protection Engineer or Consultant acceptable, and reporting directly to the Napa County Fire Marshal's Office. The Fire protection Engineer or Consultant shall be provided by the applicant at no charge to the County for the following circumstances:
- a. Independent peer review of alternate methods proposals.
- 24. Plans detailing compliance with the fire and life safety conditions of approval shall be submitted to the Napa County Fire Marshal's Office for review and approval prior to building permit issuance and/or as described above.
- 25. All post indicator valves and any other control valve for fire suppression systems shall be monitored off site by a Central Station or Remote receiving Station in accordance with NFPA 72 2010 edition.
- 26. A complete set of building drawings and civil drawings shall be submitted to the Napa County Fire Marshal's Office for plan review and approval prior to building permit issuance.

## **GROUNDWATER MEMORANDUM**

The applicant requests to establish a 30,000 gpy winery.

#### **COMMENTS:**

- 1. The parcels are located in the "Valley Floor" region.
- 2. The existing use for the parcel is estimated to be 3.65 acre-feet per year.

#### **RECOMMENDED CONDITIONS:**

1. We have reviewed the phase one, water availability analysis for the proposed project. The 10.09 acre parcel is located in the valley floor area with an extraction threshold of 1.0 AF/Acre, resulting in a total parcel threshold of 10.09 AF/Year. The estimated water demand of 4.89 AF/Year is below established threshold for the property.

---

Based on the information provided, the projected groundwater usage for all of the project parcels should not have a significant impact on static water levels of neighboring wells.

No further analysis is necessary.

The Engineering Division received a referral for comment on a modification to an existing use permit for Ideology Cellars Winery, generally requesting the following:

To establish a new winery with 4 full-time employees that allows for up to 2 alternating proprietors with an overall total production of 30,000 gallons per year. To construct a new 4,976 square foot winery building, a 3,771 square foot covered crush pad, a new 12 space parking lot, new entry sign and automatic gates at the Solano Avenue entrance, and a new wastewater treatment system. The proposal includes a marketing plan that will allow daily visitation with a maximum of 20 guests per day; six events per year with a maximum of 30 guests per event; and one event per year with a maximum of 100 guests. The marketing plan would allow "on-premise" wine consumption per Assembly Bill 2004 and the sale of wine for consumption on-premises. The project also proposes to allow for continued farm access for neighboring vineyards, improve the existing vineyard road, and to construct a new approximately 2,962 square foot single family residence over a portion of the proposed winery building to be used by the owner.

After careful review of the use permit modification package submittal the Engineering Division recommends approval of the project with the following recommended conditions:

### **EXISTING CONDITIONS:**

- 1. Napa County parcel 034-190-040 is located on the west side of Solano Avenue approximately 0.14 miles south of the intersection of Solano Avenue and Darms Lane in Napa.
- 2. The existing parcel is approximately 10.09 acres.
- 3. Parcel 034-190-040 is currently a vineyard.

#### **RECOMMENDED CONDITIONS:**

#### **PARKING:**

- 1. Any parking proposed by the applicant or required by the Planning Commission as a condition of this permit must conform to the requirements of the latest edition of the Napa County Road and Street Standards.
- 2. Structural section of all drive isles shall be calculated by a licensed Civil or Geotechnical Engineer to hold a minimum H20 loading and shall conform to the procedures contained in Chapter 600 of the State of California Department of Transportation Design Manual or approved equivalent.

#### NEW PRIVATE ACCESS ROADS AND DRIVEWAYS:

- 1. All roadway construction associated with this application shall conform to the current Road and Street Standards of Napa County at the time of permit submittal and accepted construction and inspection practices.
- 2. Access drives shall meet the requirements of a commercial drive and be a minimum of 18 feet wide with 2 feet of shoulder. Structural section shall be a minimum two inches of asphalt concrete surface over five inches of Class II Aggregate or equivalent. (County Road and Street Standards, Page 12, Par. 13).
- 3. Horizontal inside radius of curvature of roadways and driveways shall be no less than 50 ft (County Road and Street Standards, Page 14, Section 15).
- 4. All driveway access to the public right of way must conform to the latest edition of the Napa County Road and Street Standards (Page 65, Detail P–4). Outbound driveway widths shall be a minimum of 25 feet to accommodate turning movements of large trucks.
- 5. Applicant shall provide an emergency vehicle turnaround facility within 50 ft of any proposed new buildings (County Road and Street Standards, Page 35).
- 6. The applicant must obtain an encroachment permit prior to any work performed within the Napa County Right-of-Way.
- 7. The applicant must obtain an encroachment permit from the California Department of Transportation for any work performed within the State Right-of-Way.

#### SITE IMPROVEMENTS:

- 8. All on site civil improvements proposed including but not limited to the excavation, fill, general grading, drainage, curb, gutter, surface drainage, storm drainage, parking, and drive isles, shall be constructed according to plans prepared by a registered civil engineer, which will be reviewed and approved by this office prior to the commencement of any on site land preparation or construction. Plans shall be submitted with the building and/or grading permit documents at the time of permit application. A plan check fee will apply.
- 9. Proposed drainage for the development shall be shown on the improvement plans and shall be accomplished to avoid the diversion or concentration of stormwater runoff onto adjacent properties. Plan shall also indicate the path and changes in runoff.
- 10. Grading and drainage improvements shall be constructed according to the latest "Napa County Road and Street Standards" and the California Building Code. Specifically, all cuts and fills slopes shall be setback to meet the latest CBC.
- 11. If excess material is generated that cannot be used onsite, the Owner shall furnish to the Napa County Planning, Building and Environmental Services Department evidence that the Owner has entered into agreements with the property owners of the site involved and has obtained the permits, licenses and clearances prior to commencing any off-hauling operations.

#### **OTHER RECOMMENDATIONS:**

- 12. Prior to the granting of occupancy (be it temporary or final) of any new building permits associated with this Use Permit and/or prior to any increase in visitation or marketing, the driveway and parking improvements as outlined above shall be implemented.
- 13. Portions of parcel 034-190-040-000 fall within a FEMA designated Special Flood Hazard Area (SFHA) Zone A per Flood Insurance Rate Map (FIRM) 06055C0505F. Therefore, any work proposed within the SFHA shall comply with chapter 16.04 of the Napa County Code. Applicant shall have an engineer supply additional base flood data to establish a Base Flood Elevation (BFE) using either the simplified method or the detailed method as outlined in Napa County Code Chapter 16.04.540 and in more detail in the FEMA guideline "Managing Floodplain Development in Approximate Zone A Areas A Guide For Obtaining and Developing Base (100-Year) Flood Elevations".

#### CONSTRUCTION STORMWATER REQUIREMENTS:

14. Any Project that requires a building or grading permit shall complete a Napa County Construction Site Runoff Control Requirements Appendix A - Project Applicability Checklist and

shall submit this form to the Napa County Planning, Building and Environmental Services Department for review.

- 15. All earth disturbing activities shall include measures to prevent erosion, sediment, and waste materials from leaving the site and entering waterways both during and after construction in conformance with the Napa County Stormwater Ordinance 1240 and the latest adopted state regulations. Best Management Practices (BMPs) shall also be implemented to minimize dust at all times.
- 16. Any construction activity that equals or exceeds one acre of total disturbed area shall prepare a Stormwater Pollution Prevention Plan (SWPPP) in accordance with the regulations of California Regional Water Quality Control Board (SRWQCB) and shall file a Notice of Intent (NOI) prior to commencement of any construction activity. The completed SWPPP shall be submitted to the Napa County Planning, Building and Environmental Services Department for review.
- 17. All hazardous materials stored and used on-site during construction that could cause water pollution (e.g. motor oil, cleaning chemicals, paints, concrete, etc.) shall be stored and used in a manner that will not cause pollution, with secondary containment provided. Such storage areas shall be regularly cleaned to remove litter and debris. Any spills shall be promptly cleaned up and appropriate authorities notified.
- 18. All trash enclosures must be covered and protected from rain, roof, and surface drainage.
- 19. The property owner shall inform all individuals, who will take part in the construction process, of these requirements.

#### **POST-CONSTRUCTION RUNOFF MANAGEMENT REQUIREMENTS:**

- 20. Project must conform and incorporate all appropriate Site Design, Source Control and Treatment Control Best Management Practices as required by the Napa County manual for *Post-Construction Runoff Management Requirements* which is available at the Planning, Building and Environmental Services Department office.
- 21. Post-development runoff volume shall not exceed pre-development runoff volume for the 2-year, 24-hour storm event. Post-development runoff volume shall be determined by the same method used to determine pre-development conditions. If post-development runoff volume exceeds pre-development runoff volume after the site design BMPs are incorporated into the project's overall design, a structural BMP (e.g. bio-retention unit) may be used to capture and infiltrate the excess volume.

- 22. Loading/unloading dock and processing areas must be covered or designed to preclude stormwater run-on and runoff. All direct connections to storm drains from depressed loading docks (truck wells) are prohibited.
- 23. Parking lots and other impervious areas shall be designed to drain through grassy swales, buffer strips, sand filters or other sediment control methods which will be approved by this Department. If any discharge of concentrated surface waters is proposed into any "Waters of the State," the permittee shall consult with and secure any necessary permits from the State Regional Water Quality Control Board prior to the issuance of applicable construction permits.
- 24. In design of retention facilities, the maximum percolation rate shall be two inches per hour.
- 25. For on-site common retention basins, the side slopes shall not exceed 3:1.
- 26. Provide concrete stamping, or equivalent, of all stormwater conveyance system inlets and catch basins within the project area with prohibitive language (e.g., "No Dumping Drains to Napa River"). Signage shall identify the receiving water the drain discharges to and include a message in Spanish.
- 27. Trash storage areas shall be paved with an impervious surface, designed not to allow run-on from adjoining areas, and screened or walled to prevent off-site transport of trash. Trash storage areas must contain a roof or awning to minimize direct precipitation or contain attached lids on all trash containers that exclude rain.
- 28. Prior to final occupancy the property owner must legally record an *"implementation and maintenance agreement"* approved by the Public Works department to ensure all post-construction structures on the property remain functional and operational for the indefinite duration of the project.
- 29. Each year the entity responsible for maintenance is required to complete an annual report. The report shall be signed by the property owner and include copies of completed inspection and maintenance checklists to document that maintenance activities were conducted during the previous year. The annual report shall be retained for a period of at least five years and made available upon request by the County.

### Any changes in use may necessitate additional conditions for approval.
