Kelli-

I represent what is arguably the largest and certainly the most dense population center that could be affected by the numerous wells and reservoirs planned in subject project. Hall well #4 is located ABOUT 1800 FEET from the some 16 horizontal wells that Circle Oaks uses to supply about one third of its water supply and about 3400 feet to our main vertical well (two thirds of our supply). The health of these wells is critical to over 500 persons in this District.

I request that the 45 day comment period be extended for an additional 45 days AND I request that the project not be allowed to go forward without a test to measure the effect on Circle Oaks water sources.

In addition to the above, why would Napa County approve a project that consumes such a large amount of water in a state declared drought year?
