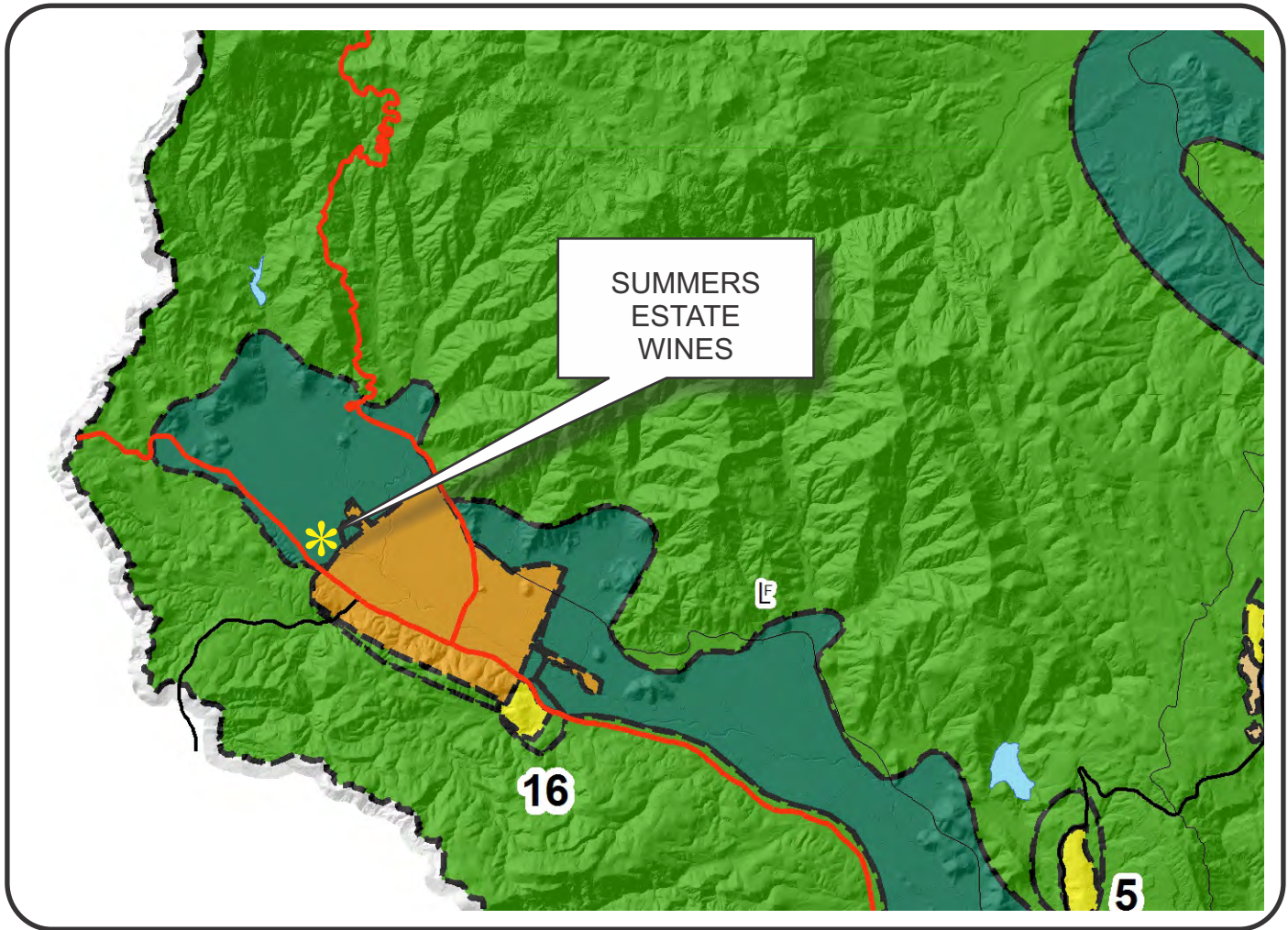


NAPA COUNTY LAND USE PLAN 2008 - 2030

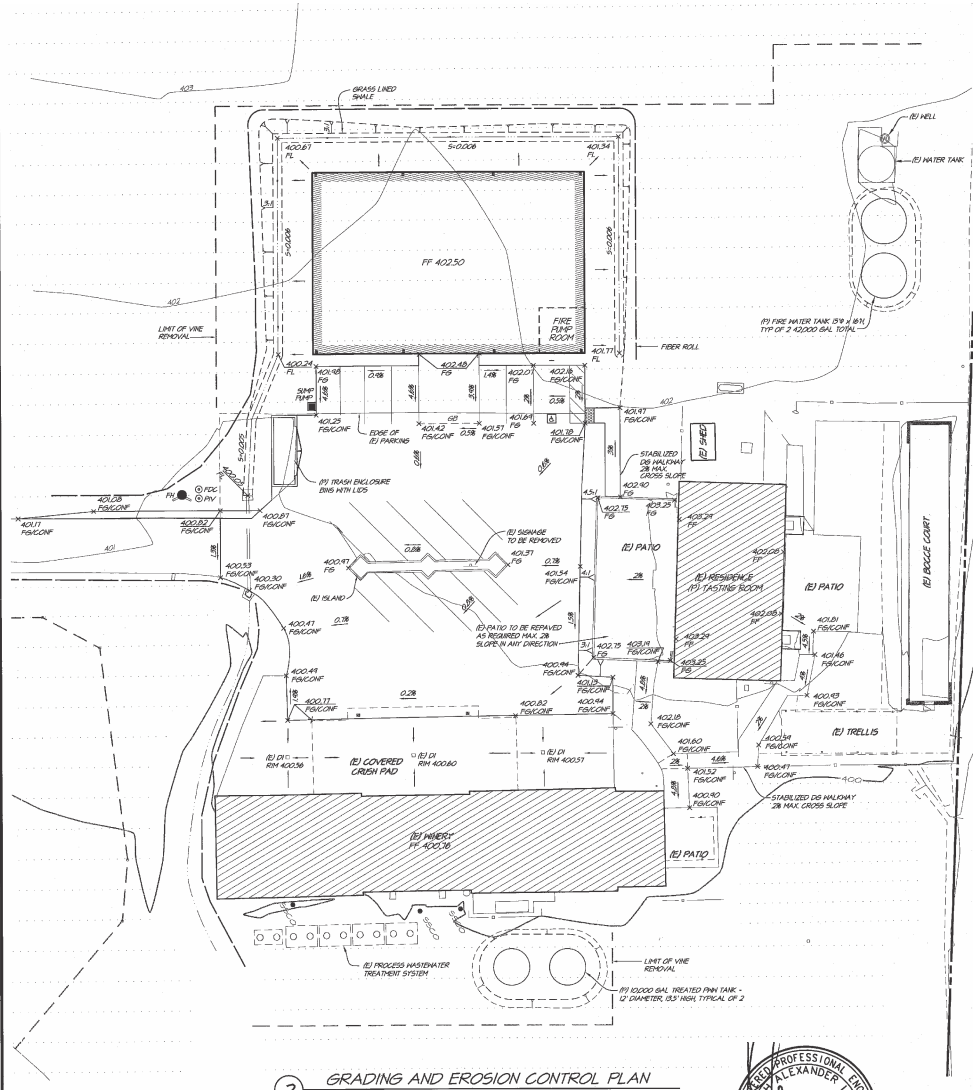

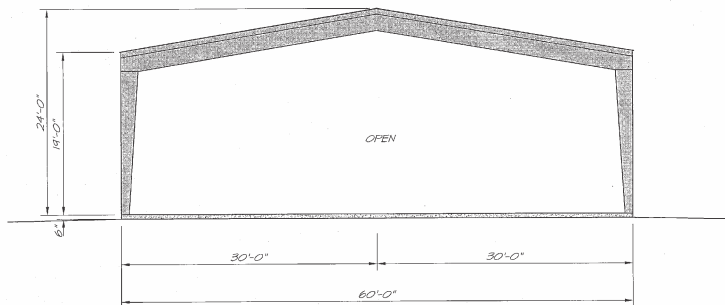

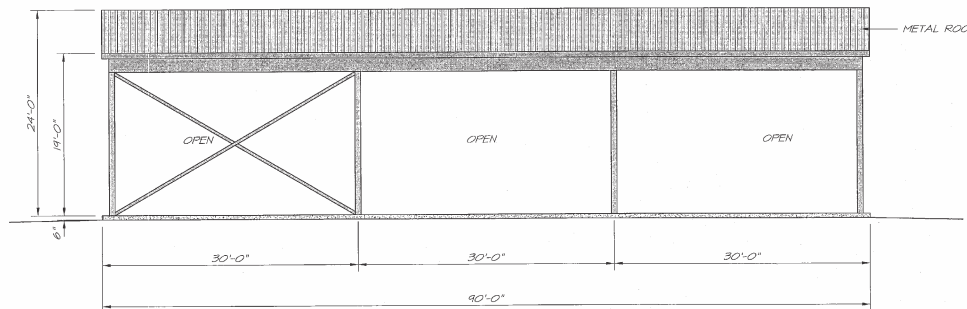

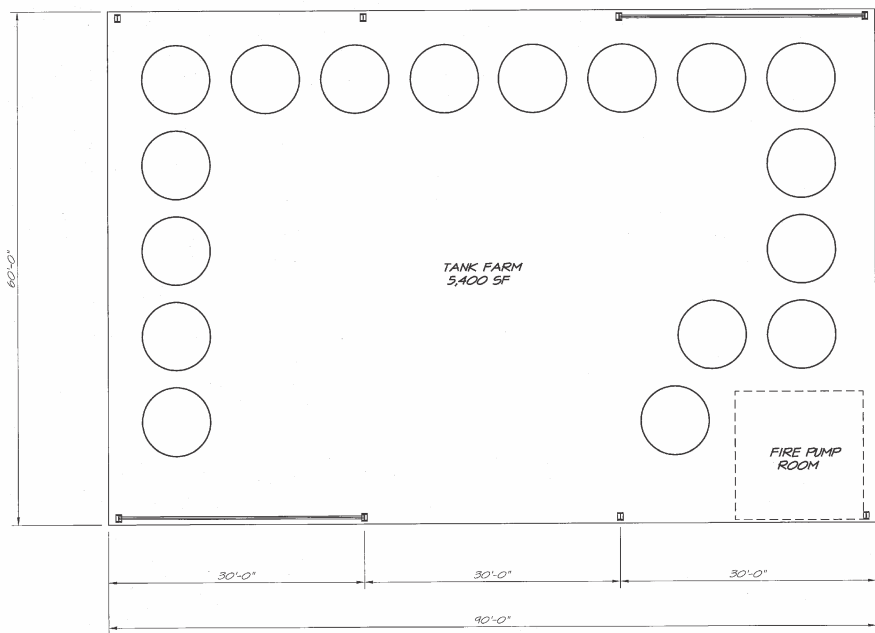

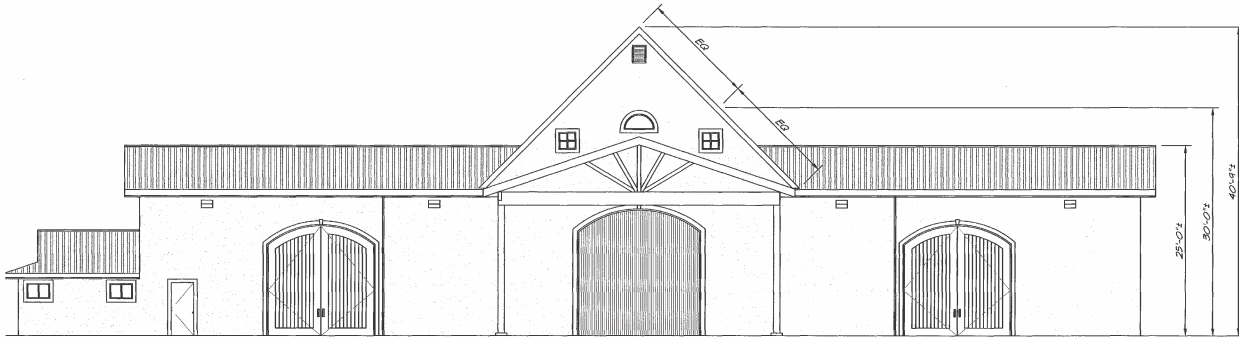


1 (P) COVERED TANK FARM FLOOR PLAN

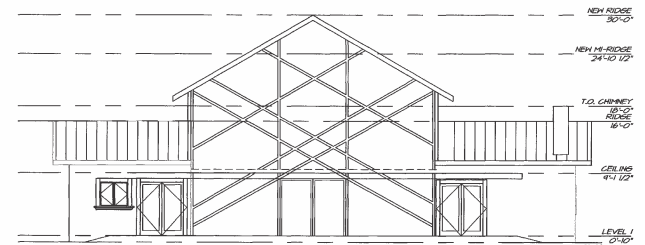


TANK FARM FLOOR PLAN AND ELEVATIONS

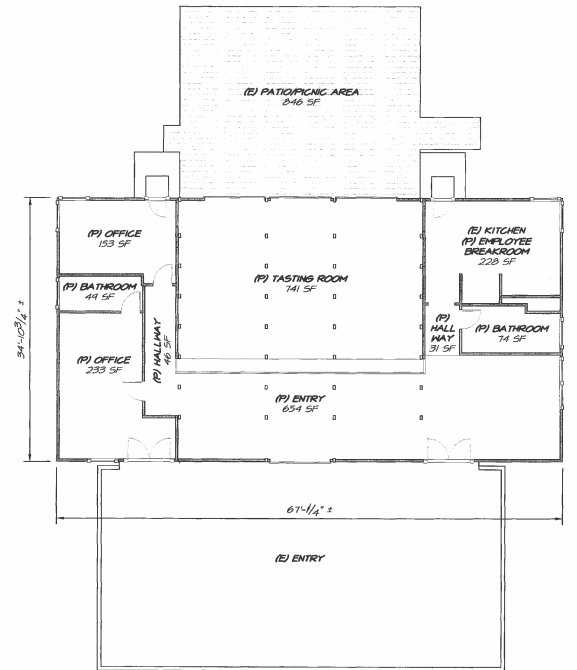

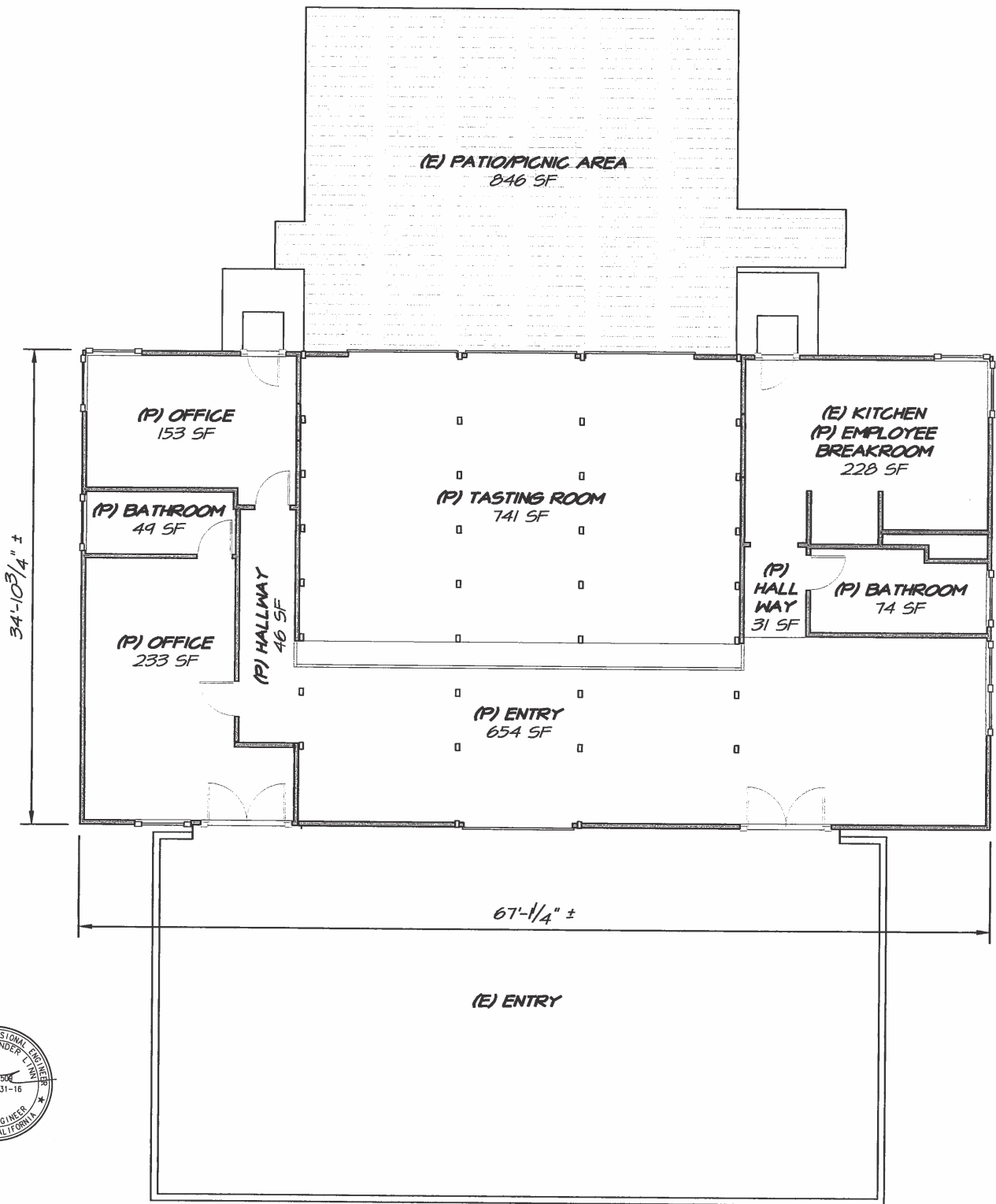


1 EXISTING RESIDENCE - PROPOSED TASTING FLOOR PLAN

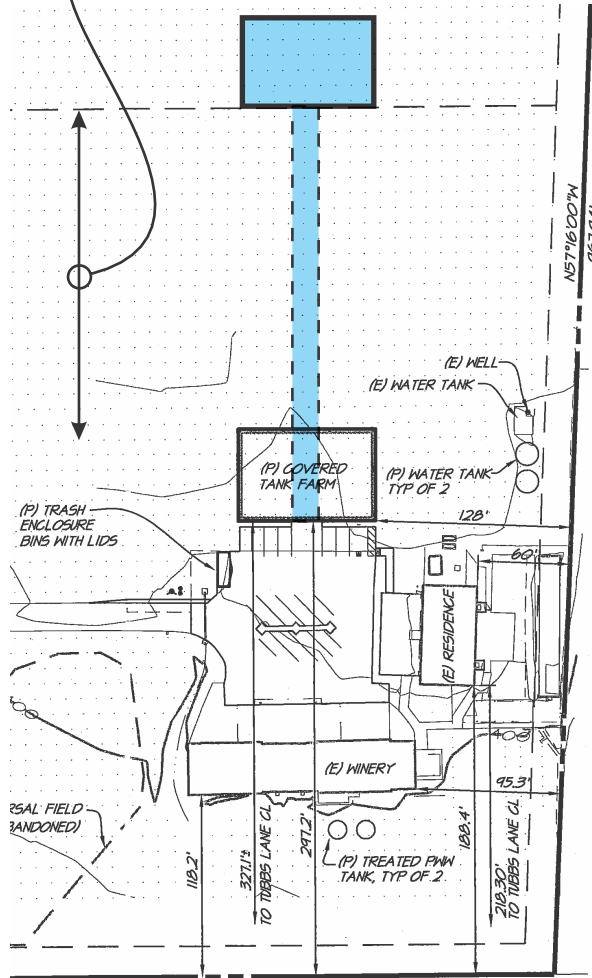

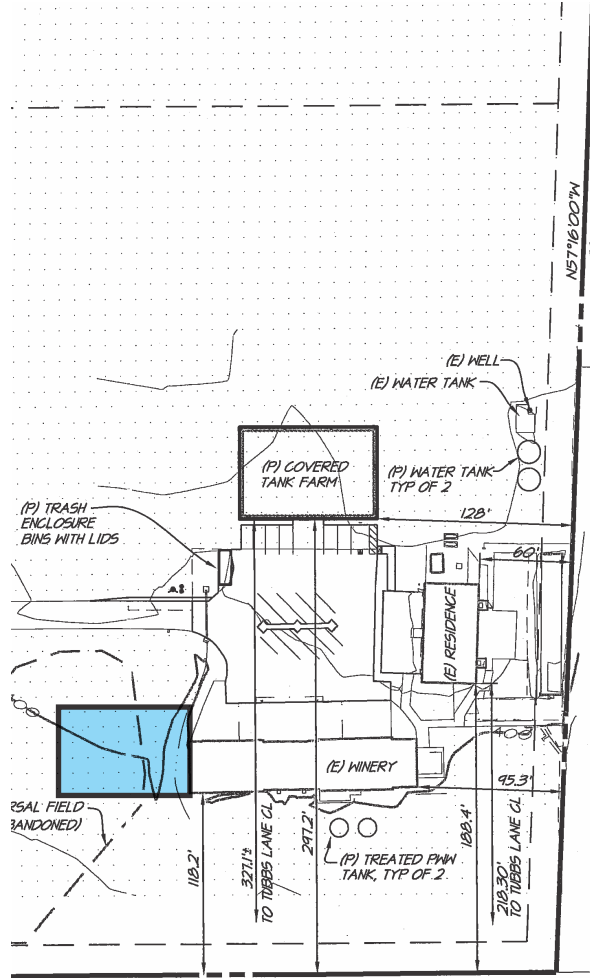

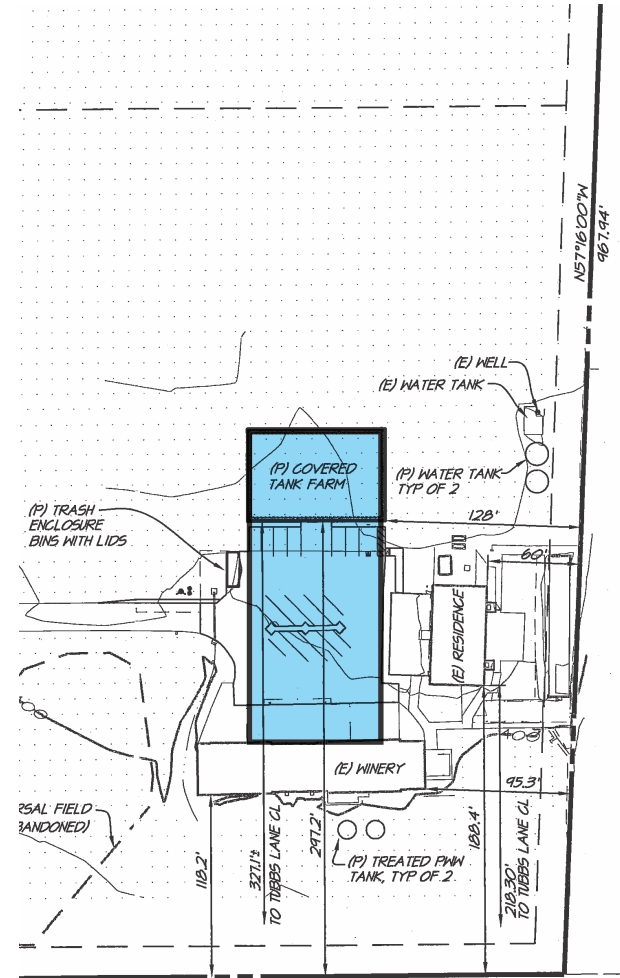
